

"Civil Rights and Equal Rights Under the Law"

Presenters - Sharon Freilich and Benjamin Zivyon

The Supreme Court has agreed to decide whether a Colorado baker discriminated against a gay couple when he declined to bake a cake for their wedding. The Supreme Court said that it would hear the case -Masterpiece Cakeshop, Ltd. v. Colorado Civil Rights Commission. The case asks the high court to balance the religious rights of the baker against the couple's right to equal treatment under the law. Similar disputes have popped up across the United States. The Orthodox Union and the Rabbinical Council of America jointly filed a brief with the Supreme Court delineating a position on this case. Sharon and Ben will share a forum discussing the case and the position taken by the OU and the RCA.
