MEMBERSHIP TYPES and COSTS:

Independent Professional Member – Individual (\$200.00):

Join as a licensed **Independent Professional Member - Individual** and receive full access to NAILTA. Eligibility governed by NAILTA Bylaws.

Membership includes:

- Individual listing and individual voting rights.
- Opportunity to advertise membership in NAILTA as described in the advertising guidelines.
- Receive NAILTA communications and be invited to participate in NAILTA sponsored training, activities and events at the members-only rate.
- Participate in critical, industry-changing NAILTA Committees and Offices.

Independent Professional Member – Corporate (\$250.00 plus add-ons):

Join as a licensed **Independent Professional Member - Corporate** and receive full access to NAILTA. Eligibility governed by NAILTA Bylaws. Membership includes up to three (3) additional members (one designated voting rights member and two additional non-voting rights members). Dues for **additional employee** non-voting rights members are **\$25.00 per person**.

Membership includes:

Associate Member (\$300.00 plus add-ons): Includes Industry Partners, Supporters and Underwriters. Eligibility governed by NAILTA Bylaws. Membership includes corporate or individual associate membership **plus additional employees** designated as non-voting associate members for **\$25.00 per person**.

Membership includes:

- Participate in critical, industry-changing NAILTA Committees.

MEMBERSHIP DUES and POLICY:

Membership Dues are assessed annually and due by the 30th of June. Dues for new members joining the Association **for the first time** are prorated on a quarterly basis. New members joining between:

- April 1st and June 30th will pay 100% of the annual dues.
- July 1st and September 30th will pay 75% of the annual dues.
- October 1st and December 31st will pay 50% of the annual dues.
- January 1st and March 30th will pay 25% of the annual dues.

All future dues payments will be at the annual dues rate. Membership will be terminated thirty (30) days after the date of notice of non-payment of dues. Membership of any class in the Association shall require the affirmative vote of the Board of Directors or their appointees. All applications for membership must be performed online or in writing and mailed to the Association. As a condition precedent to membership in this Association, an applicant must agree to abide by the Professional Ethical Standards of Conduct and agree to be governed by the Bylaws of the Association which are available for review on the website at www.nailta.org and incorporated herein by reference. Failure to follow governing rules and standards may result in termination of membership rights and/or expulsion from the organization.
