1. This year's event will be held at ONEgeneration located at 17400 Victory Blvd., Van Nuys, CA 91406 on Sunday October 22, 2017.

2. **Open to the Public:** Sunday 8am to 1pm

**Set up** Set-up beginning at 6:30(must be set-up by 8am)

**Teardown** Tear down can start at 1pm and must be completed by **2:30**

3. No deposits will be accepted. Payment must be made in full to reserve a rental space. All proceeds from the boutique sales go to the crafter/vendor.

4. The event committee reserves the right to refuse any display or items for sale deemed inappropriate.

5. Once Vendor's registration is accepted, all fees are non-refundable. Vendor agrees to pay ONEgeneration \$20 for any returned check.

6. Each vendor is responsible for its/his/her own money, cash box, and sales receipts. ONEgeneration will not provide this service, or make change.

7. **Check in & parking:** Please pull into the parking lot entrance with the green farmers market flags, near the skate park. Drive to the back of the lot to the open gate. You may unload near your booth and then move your car to the parking area in the back of the lot.

8. ONEgeneration will not be liable for any damages or injury to persons or property, sustained by conditions or activities on the premises.

9. Vendors are responsible for protecting their property and merchandise from damage or loss.

10. Collection, reporting, and payment of California state sales tax is solely the responsibility of the vendor. ONEgeneration accepts no responsibility for sales tax collection.
