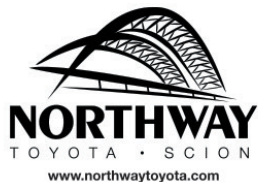
Fact: There already are powerful and growing Black and Hispanic caucuses in Congress.
