RE: Notification of Detour on GDOT Reconstruction/Rehabilitation Project  
PI 0000297, Upson County, SR 3/US 19 FM CR 73/East-West County Rd to CR 8/Atwater Rd.

The Georgia Department of Transportation (GDOT) is in the process of preparing to let the reconstruction/rehabilitation project listed above. The proposed project is scheduled to be let to construction in **November 2018**. The proposed project would consist of the following:

Widening the four lanes of US 19 to 12 feet along with a raised median. The project would begin at the intersection of US 19 and County Road and end at the intersection of US 19 and Atwater Road approximately two miles north of Thomaston. Delray Road would also be realigned to intersect with US 19 and Jimmerson Road and include a signal.

It is necessary to close the following roads to through traffic in order to complete the reconstruction/rehabilitation (see attachments). The use of a temporary detour route would be necessary for the duration of the closure. Signage would be posted 30 days in advance of the actual road closure in addition to signs detailing the route of the detour at the time of construction. Road closure and detour signs would be visibly installed for the duration of the closure.

The purpose of this letter is to provide you with advanced notification of the proposed road closure in the event of a temporary impact from the proposed project on emergency services. A proposed project location and detour map is attached illustrating the location of the proposed project and the proposed detour route.
