OFFICIAL RULES & GUIDELINES

PARADE DAY: MONDAY, DECEMBER 3RD 2018 LINE UP TIME: 4:30 P.M. START TIME: 6:00 P.M.

GENERAL RULES

- Only the official Parade Santa Claus will be allowed in the parade. Multiple Santas are confusing to children. No other live Santa Claus characters will be allowed to participate in the event.
- All entries MUST pull a decorated float. The only exceptions will be for organized, specialty car groups with prior approval.
- The only walking groups that will be allowed are Performance Groups i.e., band, dance, cheerleaders,
- An application and fee are <u>required</u> for each vehicle participating in the parade.
- Proof of insurance is required for each vehicle.
- All vehicles and floats must be decorated with a Christmas theme.
- If a vehicle is playing music, it must be Christmas-themed music at all times during the parade.
- The parade is not to be used as a platform for special interest groups or political parties. It is the express purpose of the Greater Talladega Area Chamber Christmas Parade to promote the celebration of Christmas.
- Distribution of pamphlets, newsletters, and other documentation is not allowed during the parade, on the parade route or the parade assembly area.
- The Parade Committee reserves the right to accept or decline any entry.
- Horses will NOT be allowed
- Please let us know immediately if you will be bringing a large group of vehicles or oversized vehicles such as transfer trucks.
- Vehicles may begin arriving at 4:30 pm. All participants must be at the lineup area by 5:30 pm. Be ready to start moving at 5:45 pm. The parade will begin promptly at 6:00 pm!

PAGEANT REPRESENTATIVES

- NO ONE WILL BE ALLOWED TO RIDE ON THE HOOD OR ROOF OF ANY VEHICLE. All Representatives must ride in a convertible, inside the vehicle or in the back of a truck.
- A limited number of vehicle spots are available for Pageant Representatives. The parade committee will accept the first <u>15</u> vehicles that register AND pay. More than one Representative may ride in a vehicle.
- Participants are responsible for providing legible signage on both sides of the vehicle with the name of the Pageant and the Representative's name.

HOLD HARMLESS AGREEMENT (required)

To participate in the parade, the undersigned and all participants of this entry agree to follow all guidelines and instructions given by parade officials, the Chamber of Commerce, the City of Talladega, staff, parade officials and police. Obey all laws for proper operation of a motor vehicle. Entrant and all participants agree to indemnify and hold harmless the Chamber of Commerce and related entities, all agents, employees and volunteers of said organizations, from any claim or expense of whatever kind or nature arising from activities as a parade participant of the undersigned organization and any of its representatives or individual participants. This indemnification and hold harmless agreement shall be governed in all respects under the laws of the State of Alabama.

- 6. <u>Please let us know immediately if you will be bringing a large group of vehicles or oversized vehicles such as transfer trucks.</u>
- 7. Horses will NOT be allowed
- 8. Vehicles may begin arriving at 4:30pm. All participants must be at the lineup area by 5:30pm. Be ready to start moving at 5:45pm. The parade will begin promptly at 6:00pm!
