### The Beginning

Dr. Lloyd F. Moss was born and raised in Fredericksburg, VA. A graduate of Hampden-Sydney College and the Medical College of Virginia, Dr. Moss served the U. S. Army from 1941-46, attaining the rank of major. He worked at McGuire VA Hospital until February 1948 and at Children's Hospital in Boston until June of that year. At the age of 33, he entered private practice and continued to practice medicine for 41 years. Dr. Moss retired from private practice in 1989.



On November 2, 1993, the Lloyd F. Moss Free Clinic opened thanks to the leadership and dedication of Dr. Moss. In 1994, just a year after the Clinic opened, Dr. James Shield, then -president of the Medical Society of Virginia, presented the Wyeth-Ayerst Physician Award for Community Service to Dr. Moss at the MSV's annual meeting. In doing so, Dr. Shield said Dr. Moss was being honored because "he exemplifies one of the finest things that a physician can do and he has done it exceptionally well. He has been a leader in Virginia in something that we are extremely proud of - the free clinic movement". Dr. Moss worked in the Moss Free Clinic for many, many years until his death on August 28, 2006 at the age of 90.

### Today

The Lloyd F. Moss Free Clinic, a private **501(c)(3) non-profit organization**, has been providing essential healthcare services to the Fredericksburg region for over 24 years. The majority of the Clinic's funding comes from donations from individuals, foundations, businesses, civic organizations, places of worship, and patients.

The Clinic could not provide medical services to our neighbors in need without the help of over 600 rotating on-site volunteers consisting of medical doctors, dentists, physician assistants, nurses, pharmacists, and office workers. In 2016, the Clinic served 1,921 patients through 11,726 patient visits, with the help of community members who **donated 19,666 hours of service to the Clinic and our patients**. We could not keep our doors open without the help of our dedicated volunteers and financial supporters.
