SUMMARY

Little Brownie Bakers will add a new cookie to the 2016-17 lineup. S'mores offer a s'mores-inspired crunchy graham sandwich cookie with creamy chocolate and marshmallowy filling. Little Brownie Bakers will offer the Gluten-Free Toffee-Tastic, a buttery cookie packed with golden toffee bits, as a baked to order pilot again this cookie program sale. Girl Scouts of North Central will only have **one chance** to place an order for the Gluten-Free ToffeeTtastic and S'more cookie.

FACTS ABOUT OUR OFFERING THE GLUTEN-FREE TOFFEE-TASTIC AND S'MORES COOKIES.

1. The council will place a firm order for these cookies by September 29, 2016. This order will be the **only time we will receive the** Toffee-Tastic and S'more cookies. We cannot get more, and we cannot return any we do not sell.
2. The council's cost to purchase these cookies is more than double our other varieties (\$2.25 per box – of gluten free & S'more cookies). Both varieties will be priced at \$5.00.
3. No returns will be accepted on any of the Girl Scout cookie varieties.

WHAT THIS MEANS FOR TROOPS

1. Troops registered by September 29, 2016 for the 2017 membership year will have the opportunity to pre order Toffee-tastic and S'more cookies and receive them at initial order delivery in late January.
2. Troops registered for the 2017 membership year by September 29, 2016 can submit the Pre-Order starting August 10th. Troops will be required to complete the Pre-Order form to guarantee receipt of Toffee-Tastic and S'more cookies.
3. There will not be a limit on the number of cases of cookies a troop commits too. However, this is a **COMMITMENT**. By completing the survey, your troop is committing to that number of cases for Toffee-tastic and S'mores on their INITIAL ORDER.
4. Whatever you commit to during the Pre-order phase, will be what your troop will receive at initial delivery; no more, no less.
5. Council will upload all pre orders for Toffee Tastic and S'more into eBudde™ starting December 1st.
6. Based on the 2016 sale, there will be a small demand for a gluten-free cookies, but it will not be a top seller.

WHAT THIS MEANS FOR TROOPS (continued)

7. We **do not** anticipate having many “extra” cases on hand once initial orders have been filled.

WHAT HAPPENS NEXT?

1. If your troop is returning and you do not place an order for Toffee Tastic and S’more and the deadline date has expired. You will have to check the cupboards when they open for those varieties.
2. If your troop is new and is not registered before the deadline, and you would like to place a pre-order for the Toffee-tastic and S’more cookie, you must make sure you are registered by September 29, 2016.
3. When the Pre-Order form is available, please complete specifying the number of cases of Toffee-tastic and S’more cookies you would like to receive. Even if your troop has decided not to sell them, complete it with a quantity of zero. We will be using this information to place our council order.
