



LEGAL TRACK

Session 1: Predicting what the Trump administration will do regarding infrastructure, tariffs, immigration, and existing regulations. Also, recent legal decisions that impact subcontractors.

Session 2: Compliance strategies for our region's mosaic of Sick Leave laws. Compliance refresher every Human Resources person needs regarding affirmative action, EEO, persons with disabilities (section 503), and veterans (VEVRA). How to be prepared for an OFCCP audit.

Session 3: Claims Prevention: payment collection techniques before resorting to liens and bonds; subs' rights when work is suspended; subs' influence in bid protests; and much more.

Session 4: Dispute Management: the role of consultants and experts, how technology is changing discovery, liquidating agreements, what to do if a GC defaults or if you are a second-tier sub and the first-tier sub defaults, and more.

FINANCIAL TRACK

Session 1: The hidden costs and risks to subs on projects with Owner or Contractor controlled insurance programs, and how to protect your business. Understanding the exclusions, limitations and deductibles. Case studies that will surprise you.

Session 2: Maximize the costs you are entitled to when calculating your labor burden for change orders and claims. Turn your indirect costs into direct costs. Avoid committing fraud.

Session 3: The best insurance decision you will ever make is joining a group captive. Midsize companies can reduce health insurance and workers compensation costs by 35%. If you are responsible for the insurance in your company you must attend this presentation.

Session 4: Design-build and P3 best practices from a subcontractor's view point when submitting a bid, reviewing contract clauses, bonding, project financing, legal rights, and the differences between public and private ownership. Case studies will demonstrate dangers to avoid and lessons learned.

Session 1: The Internet of Construction Things – smart tools, data logging, remote operation, data transmission, people tagging, big data, and what it means to the future of our industry.
