

KENTLANDS CITIZENS ASSEMBLY
ACTIVITY RELEASE AND WAIVER

In consideration of my child's participation in **Teen Night** to be held on _April 6,_2018 ("Activity"), at the Kentlands Citizens Assembly Clubhouse ("Clubhouse"), I, the undersigned, agree to the following terms and conditions:

Kentlands Citizens Assembly, Inc. ("Assembly") feels it is important the **Parents/Guardians/Caregivers/Responsible persons** of the participants in the Activity, who are under 18 years of age, are aware of the risks of participating in the Activity. The risk of physical injury from the Activity is possible during all phases of the Activity, and are more vast than can be identified. I hereby acknowledge that these risks can result from equipment failure and/or the negligence of others, failing to comply with rules, running, dancing, falling, tripping, jumping, sliding or landing into other participants/spectators or from just participating in the Activity. I, fully, on behalf of myself, my child, anyone under my supervision, guardianship, custody, control, or responsibility, and any individual I am accompanying to or bringing to the Activity, including those individuals identified as the "Participant" below (collectively, "**Participating Person**"), hereby agree to assume responsibility for all risks as a result of participating in or observing the Activity or being left at the Clubhouse, whether or not identified herein, known or unknown, or foreseeable. The Assembly's Clubhouse is not a nut free facility.

I acknowledge and understand that neither the **Assembly** nor its directors, trustees, officers, employees, agents, volunteers, staff, members, contractors, agents or representatives (collectively, "**Protected Parties**") provides parental supervision, direct monitoring or otherwise provides supervision of anyone participating in the Activity or while at the Activity. I agree that I assume all liability for the supervision and monitoring of the Participating Person and hold harmless and release the Protected Parties for any claims arising out of the supervision or lack thereof of the Participating Person. The Protected Parties shall not be responsible for any articles or property that are damaged, lost, or stolen at the Activity or in the Clubhouse.

I, for myself, for the Participating Person, for the Participating Person's parents, guardians, family members, heirs, successors, representatives, assigns, and anyone else who might have a claim by reason of injury, kidnapping or death of the Participating Person, hereby knowingly and intentionally release and hold harmless the Protected Parties from any and all liability and for claims related to any injury, harm, emotional distress, paralysis, or death of the Participating Person and for any damage to my or the Participating Person's property arising out of the Participating Person's participation in the Activity or presence at the Activity, including any damage caused directly or indirectly by any of the Protected Parties' negligence. I agree to indemnify, defend, and hold harmless the Protected Parties for any accidents, claims, demands, injuries, causes of action, allegations, harm or personal loss that may befall the Participating Person related to or in connection with the Activity or caused by the Participating Person. This agreement shall remain in full force and effect at all times whether my child is dropped off at the Activity by me or any one else.

This agreement is severable. If any part of it is held by a court of law to be unenforceable, the rest of it shall nevertheless be effective.
