Please join us for a live webinar on Thurs, March 29, 2018 at 10am PST for a timely and informative talk about how to counsel lactating parents on cannabis use.

On January 1, 2018, recreational use of cannabis became legal in California. However, a lack of research has created a lot of confusion about the safety of cannabis use for pregnant and lactating parents.

Dr. Stellwagen will discuss current position papers, emerging research, social justice implications, and practical advice that peer counselors and health professionals can share with lactating parents.
