ELIGIBILITY:

The Midwest Museum of American Art is pleased to announce the **38th Elkhart Juried Regional Art Exhibition, October 7 - December 4, 2016**. This all-media competition is open to artists 18 years and older who are residents of Allen, DeKalb, Elkhart, Fulton, Jasper, Kosciusko, Lake, LaGrange, LaPorte, Marshall, Newton, Noble, Porter, Pulaski, St. Joseph, Starke, Steuben or Whitley counties in Indiana and Berrien, Branch, Cass, or St. Joseph counties in Michigan. Each entrant may submit one (1) or two (2) works which must be original in concept and execution, created within the last two (2) years, not completed under instruction and not previously exhibited at the Midwest Museum or any other competition within the region.

ENTRY FEE:

\$25.00 entitles entrant to submit one entry. **\$40** for two entries. Entry fee is non-refundable. Limit up to (2) works.

ENTRIES DUE:

All works must be hand delivered **September 10** through **September 24** during **regular museum hours**: Tues.-Fri., **10:00AM - 4:00PM** or Sat. & Sun., **1:00PM-4:00PM. (Eastern Standard Time)**

SIZE LIMITATIONS:

Length or width may not exceed seven (7) feet. No work of art may exceed 100 lbs. in weight.

FRAMING & PRESENTATION:

All entries must be prepared for installation. Two-dimensional work must be framed and wired for hanging. Three-dimensional work should be self-supporting or be able to be placed on a pedestal. No installation pieces accepted. No works will be accepted that require the artist present for installation.

PICK-UP of ACCEPTED and NOT ACCEPTED WORKS:

Non-accepted work must be picked-up **September 27** through **October 2** during **regular museum hours**, Tues.-Fri., **10:00AM to 4:00PM**, or Sat. & Sun., **1:00PM-4:00PM (Eastern Standard Time)**

Accepted works must remain for the duration of the exhibition and may then be picked up **December 6** through **December 29, 2016**. All work not claimed by January 6, 2017 will then automatically be considered the property of the Midwest Museum of American Art to dispose of in any way it sees fit.

HOLD HARMLESS CLAUSE:

The greatest care will be taken in the handling of all entries, however the MMAA disclaims any liability for loss or damage in connection with the 38th Elkhart Juried Regional.

SALE OF WORK:

Unless otherwise indicated by the artist, all work is for sale. A commission of 25% on work sold is payable to the Midwest Museum. **There is no commission fee on Purchase Awards.**

AWARDS RECEPTION:

All submitting artists, friends and museum members are invited to attend and Awards Reception on **Friday evening, October 7, from 7:00-9:00P.M.**

JURORS:
