There are two types of camping sites available – with electrical hook-up or primitive without electrical hook-up. Camping fee with electrical hook-up is \$15.00 per night and \$10.00 per night without electrical.

**Veterinarian and Farrier Services** - Veterinarian & Farrier will be on call for the keuring. Any services that are rendered must be paid directly to the veterinarian or farrier at time of service. GLFHA *does not* take responsibility for your services.

**Coggins** - Please submit a copy of a current Coggins report for each horse registered with your application. **The Coggins report must be dated after September 26, 2017 for our keuring this year.** The original coggins must accompany the horse(s) as well.

2. the unpredictability of a horse's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. certain hazards such as surface and subsurface conditions:
4. collisions with other domestic animals or objects; and
5. the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the horse or not acting within such participant's ability
