Exhibition dates: November 18, 2017 to January 27, 2018

Reception: Saturday, November 18, 2017 from 2-4 pm

Deadline for Entries: October 28, 2017

Drop Off: on or before November 9, 2017

Pick up: January 27, 2018 at 4pm

Exhibit Criteria: The Whistler House Museum of Art invites all member artists to submit work for the annual Fall Juried Members Exhibition. **Works in any subject or medium will be considered for this exhibition** including paintings, drawings, sculpture, fiber art, quilts, and photography. All artists must be current with their dues in order to participate. Non-member artists may include the \$40 annual membership fee with the entry form.

Juror: **John Avakian**, award-winning artist and well-known professor of art at the **School of the Museum of Fine Arts**. For more information on Mr. Avakian go to <http://www.smfa.edu/john-avakian>.

Entry Fee: Members \$30 / Non-members can become a new artist member for \$40 with a reduced entrance fee of \$15 (\$55 total). Please mail all checks to Whistler House Museum of Art at 243 Worthen Street, Lowell, MA 01852.

Entries: JPEG images (3 maximum) will be accepted on CD or emailed to sbogosian@whistlerhouse.org. Preferred file size should be less than 2MB. Fill out and mail entry form and check. Include Title, Media, Size and Price for each image (See page 2). Number of works accepted will be determined by number of entries.

Framing Requirements: Work must be appropriately framed and ready to hang using eye screws. Gallery wrap canvases will be accepted BUT edges need to be painted/finished. **No saw tooth hangers.**

Size Restrictions: Small works and easel size works are preferred. All sculptures have to be easy to move to protect them during events.

Terms and Conditions: The Whistler House Museum of Art (WHMA) and Parker Gallery are fully insured and are protected by a 24-hour monitored security system. Artwork will be handled with due care and consideration by experienced personnel. However, the WHMA is not responsible for any accidental damage that may occur in moving or hanging the artwork. Work submitted must be original. Work that is copied or done under guidance of a tutor is not eligible. Works chosen for the exhibit must remain on display for the entirety of the exhibition. If work does not fully reflect the quality portrayed in the JPEG image, the WHMA reserves the right to eliminate it from the show. The WHMA takes a 30% commission on all sold works for members. All artwork must be for sale. Images of accepted work may be used for promotional purposes. Artists are responsible for the cost of shipping and insuring work sent to and from the museum. Submitting artwork does not guarantee inclusion in the exhibit. Artwork submitted must be available for the dates of the exhibit - no exceptions or substitutes. **Correspondence:** Please direct any email inquiries to
