Friday, August 4, 2017. [DSM V: The Basics](#)

Learn about or refresh your understanding of the DSM V through addressing the basics of the DSM, including an overview of each section. This workshop will cover the basics of psychiatric classification and will incorporate a case study of a client with a diagnosis of PTSD that illuminates how social workers can integrate the DSM in their practice. Differences between the DSM IV-TR and the DSM V will be highlighted. This workshop will prepare participants for some of the content that the LCSW examination will include.

Friday, September 1, 2017. [Using the DSM V in Bio-psychosocial Assessments and Treatment Plans with Case Studies and theoretical treatment modalities](#)

This session will focus on how social workers can incorporate the DSM V in their client assessments and treatment plans. It will also review the basics of the DSM. Various treatment modalities such as CBT, RET and Motivational Interviewing will be discussed. Bipolar Disorders, Depressive Disorders and Personality Disorders will be examined with a case study that incorporates diagnosis, assessment, and treatment planning.

In this session, participants will learn how they can use the DSM V to diagnose these mental health disorders through gaining an understanding of Diagnostic Features, Prevalence, Development and Course, Risk Factors, Differential Diagnosis, and Comorbidity. Participants engaging in this workshop will heighten their technical skills in diagnosis and treatment planning along with learning proven treatment modalities.

Robert M. Settles, LCSW received his Master in Social Work in 1985 and BS and BA in Management at Phillips University in 1976. Robert retired from Veterans Administration this summer. Robert provided individual and couples therapy for Veteran's using CBT, RET, Stages of Change, Harm Reduction and other models of therapeutic intervention as appropriate. He made follow-up calls for Veterans who have discharged from the 1A hospital and the ER with mental health diagnoses. He also coordinated with the Suicide Prevention Team on information from these calls. He also worked at the Health Science Center, Infectious Diseases Institute as a Program Coordinator. He organized and coordinated two Ryan White HIV Case Management Programs, a

Mental Health Substance Abuse counseling program and an HIV Prevention Education Program. Robert was a Supervisor the Outpatient center at Red Rock Behavioral Health Services. He was the Clinical Specialist at Community Care Managed Health Care Plans of Oklahoma. He reviewed all levels of behavioral health care for appropriateness of treatment.
