

CWB and FPE – Acceptance of Responsibility and Release from Liability Waiver

Name of the Activity or Event: CWB and FPE STEM/Sail Day-Camp

The Center for Wooden Boats (CWB) and Frog Prints e! (FPE) seek to present programs that are as safe, educational and fun as possible. The following information is not designed to diminish enthusiasm for our programs, yet we want participants to know in advance what some of the potential risks are.

Awareness of Risks

Recognizing that The Center for Wooden Boats and 'Frog Prints e!' will do their best to ensure a safe experience, I understand that there are risks and hazards inherent to my child's participation in the activities of this program. Some of the risks include, but are not limited to, cuts, broken bones, sprains, head injuries, heat exhaustion or heat stroke and drowning. I agree to assume these risks. I certify that my child is physically fit and has not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems, which preclude my child's participation in this activity or event.

To reduce the chance of injuries, I recognize that my child must follow safety instructions and refrain from behavior that is harmful to one self and others.

I understand that it is my responsibility to provide for my child's own accident and health coverage while participating in this program; and I further understand that neither The Center for Wooden Boats or Frog Prints e! provide this coverage for participants.

Authorizations

Participation

I give permission for my child to participate in supervised activities by CWB or FPE employees or volunteers at The Center for Wooden Boats, including rowing, sailing, swimming, and the use of tools.

I understand that at this event or related activities, my child may be photographed. I agree to allow my child's photo, video, or film likeness to be used for any legitimate purpose including promotional purposes by the event holders, producers, sponsors, organizers, and assigns.

Medical Treatment

I give permission for my child to be given first aid and/or cardiopulmonary resuscitation (CPR) by a qualified member of CWB and/or Frog Prints e! staff. I also give permission for my child to be transported by ambulance or aid car to an emergency center for treatment.

In the event that I cannot be contacted, I give consent to the medical, surgical and hospital care treatment and procedures to be performed for my child by a licensed physician or hospital

selected by either CWB or FPE when deemed immediately necessary or advisable by the physician to safeguard my child's health.

Release from Liability

I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including claims but not limited to, liability arising from the negligence or fault of the entities or persons released, for my child's death, disability, personal injury, illness, property damage, property theft, or actions of any kind which may hereafter occur to my child, including traveling to and from this event, the FOLLOWING ENTITIES AND/OR PERSONS: ***Frog Prints e!, The Seattle Center for Wooden Boats, and/or their directors, officers, employees, volunteers, representatives, and agents, the activity or event holders, activity or event sponsors, activity or event volunteers.*** If any portion of this release is held to be invalid, I agree that the remaining terms shall continue to be in full legal force and effect.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that CWB and Frog Prints e! and their directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of Frog Prints e! or The Center for Wooden Boats.

I CERTIFY THAT I HAVE READ THIS DOCUMENT, AND I FULLY UNDERSTAND ITS CONTENT AND AGREE TO THE ABOVE STATEMENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL.
