In addition, the barrier-free garden contains pleasant ponds, a raised planter with plants of varied textures, tastes and fragrances, and many cultivated plantings.

The garden is named in honor of Mrs. J. Millard Tawes, a former first lady of Maryland. Governor Tawes and she were the State's gracious hosts from 1959-1967.
