

## **The Congregational Development Fund Presbytery of the Twin Cities Area**

### **Description and Application Form**

#### **Fund Description**

The Congregational Development Fund has been established by the Presbytery of the Twin Cities Area to encourage or expand congregational ministry supporting innovative, and perhaps risky, ministry initiatives at the congregational level. The Presbytery anticipates that the use of these funds will result in revitalized congregations, new forms of ministry in our presbytery, growing and healthy partnerships, and most importantly, changed lives.

The PTCA's Committee on Congregational Vitality (CCV) will solicit and evaluate proposals and recommend recipients, with the Presbytery Leadership Team as the approving body. All grants will be reported to Presbytery at the meeting following their award, including a brief summary of the proposal and the grant amount. Actual proposals will be accepted beginning March 12, 2018. The deadline for applications is May 18, 2018. Grant funding will occur in late July/mid-August, 2018.

Successful applications will build on the current gifts, abilities, passions, and callings of congregations by enabling innovative new or expanded ministries. Up to \$100,000 in grants annually will be available from this fund.\* A ceiling of \$20,000 annually will ordinarily be applied to individual grants; however, grant proposals with multi-year horizons and funding needs may be considered. Funding preference will be given to proposals in which a clear commitment of a congregation's own human or financial resources is also present. Grants from this fund are not to be for annual budget support of a congregation. The funds may be used for capital improvements, if those improvements are clearly linked to an opportunity for new or revitalized ministry.

*\*The fund was established from the sale of Arlington Hills Presbyterian Church. That Session requested that special consideration be given to the three congregations receiving most of Arlington Hills' former members— North Church, North St. Paul; Presbyterian Church of the Way, Shoreview; and Trinity Presbyterian Church, Woodbury. The presbytery honored that request stating that those three congregations' applications would receive priority for grant funds for a period of five years. This is the second year of the grant program.*

## **General Parameters for Decision-Making**

In evaluating applications, the Committee on Congregational Vitality and the Presbytery Leadership Team will consider the following qualities and criteria:

1. Does this proposal have the likelihood of leading to growth in involvement in ministry from amongst current and possibly future members?
2. Does this proposal reflect original and creative thinking for this particular congregation? Does it introduce a new idea or practice for this congregation? What 21<sup>st</sup> century ministry challenge does it address? Does it suggest the possibility of significant positive change?
  - a. Would the presbytery be proud of this proposal? Is the outcome one that other congregations in the presbytery might learn from?
  - b. Does this proposal help this particular congregation move in a future-oriented direction?
3. Has the congregation demonstrated a willingness to change and be changed by new ideas? Is the congregation prepared and equipped for change?
4. If this project is a success, can it become sustainably funded by the congregation in future years?
5. Does the congregation have the right leadership in place to carry out and honestly evaluate this proposal?
6. If the proposal has a multi-year horizon, is there sufficient oversight and reality-based awareness so that the project can be terminated or altered quickly to give the presbytery more opportunities for successful proposals?
