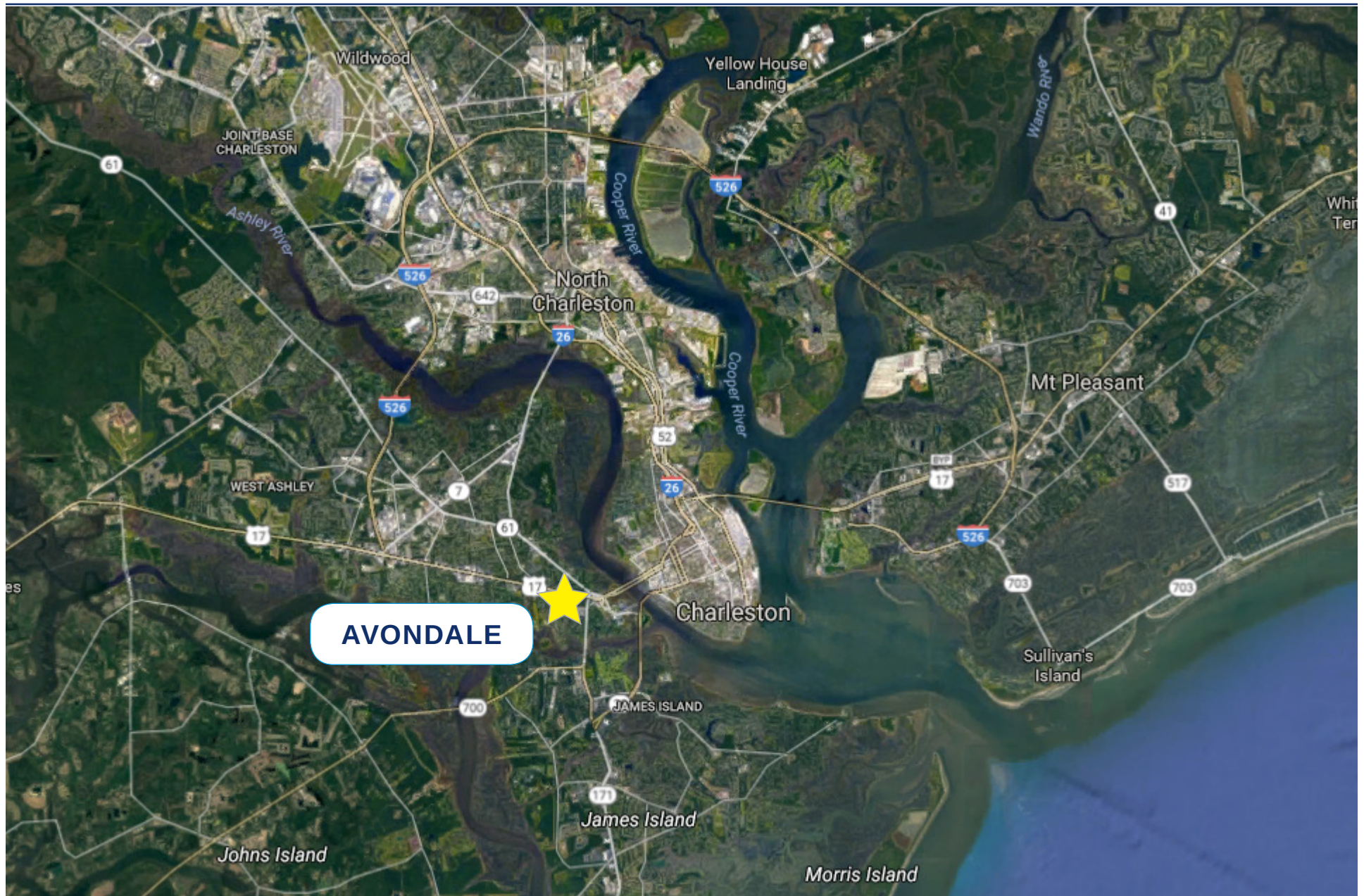

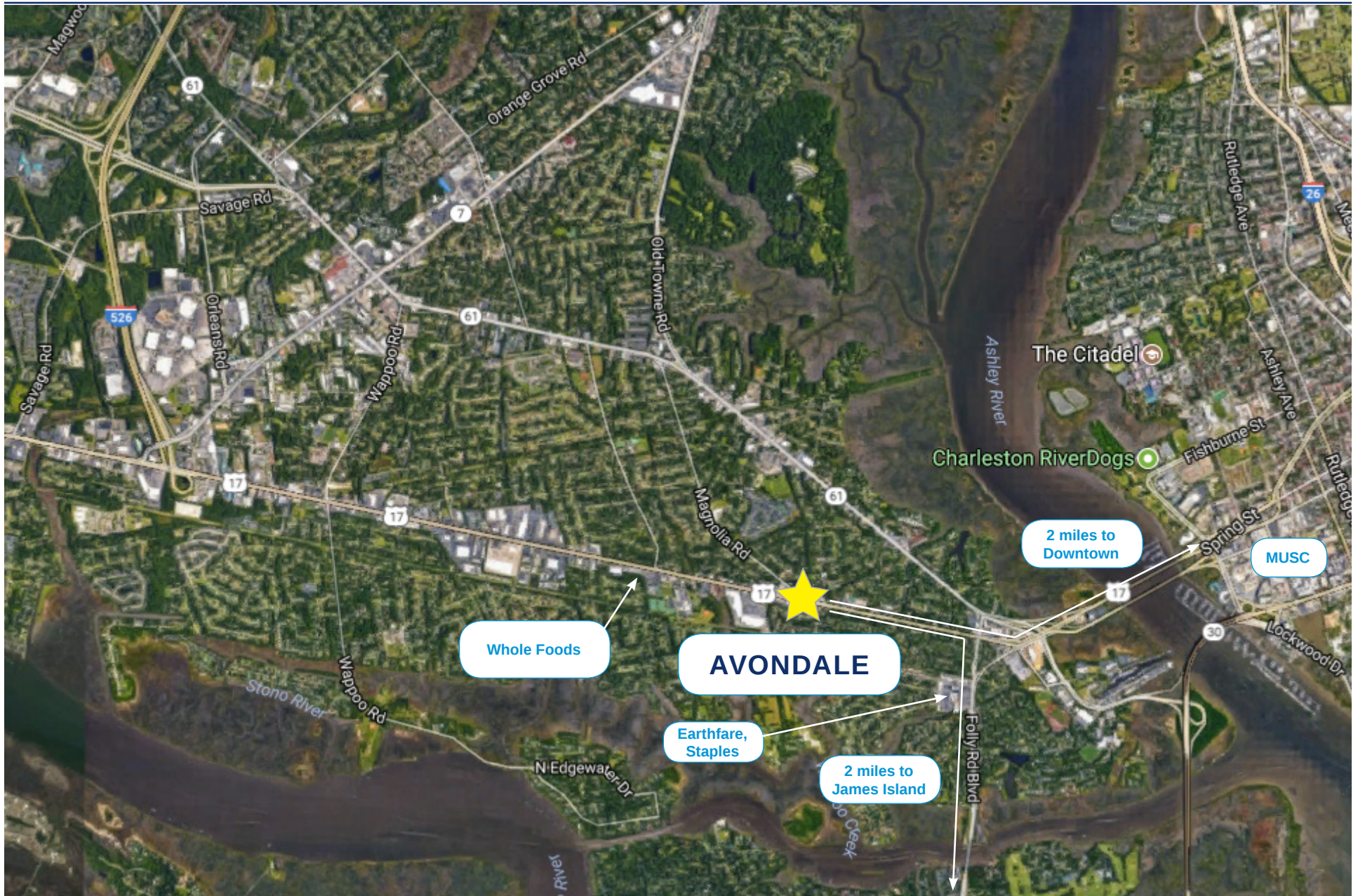


High Locator Map
