Dear Commissioner Moss,

As I'm sure you are aware, several individuals have tragically lost their lives recently due to terrible car accidents on the Miami-Dade County portion of Card Sound Road. Numerous constituents have reached out to my office expressing their concerns, and as the area in question falls within Miami-Dade County's jurisdiction, I'd like to request your assistance in addressing this hazardous public safety issue.

The road in question is a narrow rural two way roadway with several signs informing drivers of the 55 mph speed limit and "No Passing Zone". Unfortunately these devices have proven to be insufficient to deter drivers from speeding or illegally and dangerously passing other vehicles.

Given the circumstances, I appeal to you to commission an engineering study to determine the most effective calming devices that could be installed on this twelve mile segment of road. Road rumblers, delineators or other measures might be considered; and I firmly believe that anything that could save someone's life should be pursued.
