All attendees should 1st sign in @ the Visitor's Center off Norton Drive. They will issue a parking pass, then proceed to the Administration Building on 1 New Bond St. where parking is available.

- Follow I-290 West to Exit 19 (I-190 North)
- On I-190 North, take Exit 1 (Route 12/Gold Star Boulevard)
- At end of ramp quickly move to left lane, take first left (I-190 North/ Leominster/Fitchburg), and immediately bear right onto Norton Drive
- Follow Norton Drive to traffic light and turn right into Saint-Gobain
