Colonel Gerard F. Ryan, Jr. is Deputy Commander of the Air Force Operations Group (AFOG), a Field Operating Agency providing comprehensive decision support by facilitating immediate situational awareness of world-wide AF operations and integrating air and space operational expertise for the SECAF/CSAF. The AFOG is responsible for the CSAF's Crisis Action Team (CAT) and executes plans for evacuation of US Government leaders ensuring the continued performance of HQ USAF mission essential functions and continuity of operations. The AFOG provides weather support to the SECDEF, CJCS, SECAF, CSAF, and CSA as well as joint weather support to the President of the United States, the White House Military Office and Marine Helicopter Squadron One. The AFOG executes the Critical Asset Risk Management program to limit the risk of loss to \$17B of critical assets. Additionally, oversight of Civil Air Patrol policy, operational employment, organization and training is conducted within the AFOG. The Counter Drug program executes \$4B supervising Air Force activities in support of the DoD Counter Narcotics mission. Finally, the AFOG provides guidance and sets policy for Air Force aviation support to public and military events, to include all funeral flyovers.



Colonel Ryan received his commission in 1991 through the Air Force Reserve
Officer Training Corps as a Distinguished Graduate at Manhattan College, Bronx, New York. He has served at the squadron, group, MAJCOM, HQ Air Force and HQ ISAF/RS level in various capacities. He is a Special Operations Master Navigator with over 3,760 flying hours as Evaluator and Instructor in C-130E/H and MC-130H. He was selected as initial Cadre for the MC-130H Weapons Instructor Course in the USAF Weapons School. Colonel Ryan has served in 14 combat, contingency, humanitarian and disaster relief operations in Turkey, Cuba, Haiti, Bosnia, Saudi Arabia, Panama, Kosovo, Afghanistan, and JTF- Katrina. Prior to his current position, he was Chief, Middle East Region, Operational Engagement Talks, Air Force Operations Group, Headquarters Air Force.
