



**Bahia Corinthian Yacht Club**  
**2017 Club Championship Regatta**  
**Amended Notice of Race**

**Bahia Corinthian Yacht Club (BCYC) is the Organizing Authority for this Regatta**

**1. RULES**

The Regatta will be governed by the Racing Rules of Sailing (RRS) and the Class Rules of the Harbor 20 Fleet Association.

**2. BOATS**

2.1 BCYC will provide Harbor 20's for use by the competitors without boats.

2.2 Boat owners may race their own boats

2.3 Competitors on borrowed boats shall not make any adjustments or changes to the boat

2.4 Tiller extensions shall not be used.

**3. DIVISIONS**

There will be a FAMILY Division and a CHAMPIONSHIP Division.

**4. ELIGIBILITY**

4.1 FAMILY Division

4.1.1 The skipper must be a member in good standing of BCYC.

4.1.2 Crew members may be the skipper's immediate family members (spouse, son, daughter), the skipper's prior and next generation family members (parents, grandparents, grandchildren), the skipper's family members (brother, sister, uncle, aunt), or the skipper's significant other.

4.1.3 Junior members of BCYC will also be considered "family".

4.1.4 A minimum of three (3) are required aboard (skipper and at least two crew members).

4.2 CHAMPIONSHIP Division - The skipper and crew must be members in good standing of BCYC.

4.3 Skippers in each Division must possess the necessary sailing skills to safely maneuver the provided boat.

**5. ENTRY FEE**

5.1 The entry fee for the FAMILY Division is no charge.

5.2 The entry fee for the Championship Division is \$35.00 per boat.

5.3 The entry fee must be received no later than 1700 of the day before the first race.

**6. SAILING INSTRUCTIONS**

Sailing Instructions will be available no later than one (1) day prior to the first race at the BCYC Office, and on the internet at [www.bcy.org](http://www.bcy.org).

## **7. SCHEDULE**

7.1 The schedule is as follows:

- 10 AM Skipper's Meeting for Family Division skippers and crew.
- 11:30 AM is the scheduled warning signal for the first race of Family Division.
- Three races are scheduled for the Family Division.
- 12:30 PM Skipper's Meeting for Championship Division skippers and crew.
- 2:00 PM is the scheduled warning signal for the first race of the Championship Division.
- Five races are scheduled for the Championship Division.

## **8. COURSES and RACING AREA**

8.1 Courses will be windward-leeward or as signaled by the Race Committee.

8.2 The racing area will be in Newport Harbor.

## **9. PENALTIES**

A One-Turn Penalty shall apply. This changes RRS 44.1.

## **10. SCORING**

10.1 Scoring will be in accordance with *RRS* Appendix A

10.2 There are no throwouts. This changes *RRS* A2

## **11. PRIZES**

11.1 Family Division trophies will be awarded after the last race.

11.2 Championship Division trophies will be awarded after the last race.

## **12. DAMAGE DEPOSIT**

12.1 A refundable damage deposit of \$500 is required at the time of entry. After inspection, the deposit will be returned if there is no damage to the boat, sails, and rigging.

12.2 The deposit is required for every boat regardless of Division.
