April 1, 2017:	Two letters of Recommendation (submitted by a board certified Veterinarian in any specialty or VTS in any specialty who is able to testify your expert level of skill)
Dec 31, 2017	Application for 2018 due 11:59:59 CST
August 2018:	Examination: Date and location details are being finalized
