

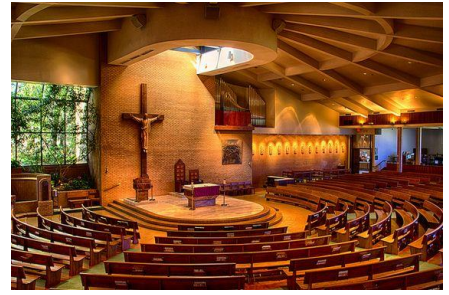

## **PRESENTERS**

### **James Anderson, Captain, Oklahoma County Sheriff's Office**

- Jim is in his 25th year with the Sheriff's Office. During that time he has been assigned to Detention, Communications, Protective Services, Patrol, K-9 and Training. He now Commands the Training Division and Tactical Team. He is a graduate of the OSBI Developing Executive Leaders in Law Enforcement and the 251st session of the FBI National Academy.

### **Chris Cook, Detective Sergeant, Edmond Police Department**

- Chris has been employed by the Edmond Police for more than 18 years and served as an investigator for 12 and a half years. Detective Cook was the lead sex crimes investigator for seven years and is now investigating family violence cases. He is also Director of Security for the Henderson Hills Baptist Church for the past eleven years and was a security officer for 7 years prior to that.

### **Felicia Jackson, Licensing & Special Services Section Manager, OK Bureau of Investigation**

- Felicia has been with the OSBI since 2000 when she became the agency's training coordinator. Since 2007, Felicia has managed the Self-Defense Act Handgun Licensing Unit and the Criminal History Reporting Unit. She has a Bachelors in Letters, a Masters in Adult Education and a Juris Doctorate of Law from the University of Oklahoma.

### **Glenn A. Moore, Protective Service Advisor, U.S. Dept of Homeland Security, OK District**

- Glenn supports homeland security efforts by assisting with the identification, assessment, monitoring, and minimizing the threat risk at the local level. He also facilitates, coordinates, and performs vulnerability assessments for local infrastructure and assets, and acts as a physical and technical security advisor to Federal, state, and local law enforcement.

### **Kurt Stoner, Special Agent, FBI Oklahoma City**

- Kurt received a bachelor's degree in Biology from Kansas State Univ in 1991 and is in his 25<sup>th</sup> year of law enforcement. He began his career serving six years as a police officer in Garden City, KS. Kurt is currently in his 19<sup>th</sup> year with the FBI. Most recently, he has served the OKC Field Office as Senior SWAT Team Leader, Principal Firearms Instructor, Principal Tactical Instructor, Training Coordinator and FBI National Academy Coordinator.

### **Jeff Zelnicek, Captain, Edmond Fire Department**

- Jeff has served with the Edmond Fire Dept for over 28 years and is a Captain at Fire Station 2. He has been an EMT for over 27 years and is involved with the Critical Incident Stress Management Team for 21 years. Jeff also serves as a member of the EFD Honor Guard.

### **John Whetsel, Sheriff, Oklahoma County Sheriff's Office**

- John is in his 21st year and sixth term as Sheriff. He began his law enforcement career in 1967, joined the Choctaw Police in 1973 and served as Police Chief for 21 years before being elected Sheriff. Sheriff Whetsel has an Associate degree in Police Science, a Bachelor degree in Government and Sociology, and Master's studies in Criminal Justice.

### **Rockie Yardley, Technical Investigator & Bomb Disposal Technician, Edmond Police Department**

- Rockie is in his 37<sup>th</sup> year with the Edmond Police Dept. serving as Senior Crime Scene Investigator and Senior Bomb Disposal Technician. He has also instructed for the US State Department's Counter-Terrorism Assistance Program. Before previously served as a Paramedic Supervisor for AmCare Ambulance Service in Oklahoma City.
