NJ HFMA will be hosting a FREE on-site certification review and exam sessions for **Module I and II**:

- Wednesday, October 4th: 9 am – 1 pm: Group on-site study review session for Module I
- Wednesday, October 4th: 3 pm – 5 pm: Module I exam
- Thursday, October 5th: 1:30 pm – 5 pm: Module II exam

IMPORTANT NOTE: Participants are expected to have registered and read all the materials provided for Module I prior to attending the Review and Exam Group Sessions.

The revised Certification exam is divided into two Modules:

- Module I walks you through the key concepts and helps you develop an understanding of the pieces that make up the healthcare industry.
- Module II takes the skills learned in Module I and tests you with a series of case studies. Module II is only available once you pass Module I exam.

The review session will connect the CHFP study guide concepts to practical applications to help you prepare for the CHFP exam. Taught by subject matter experts, this course will utilize high level real-world examples, giving you the opportunity to ask questions and hone your knowledge. Each of the experts are CHFPs or HFMA's and have experience with the exam questions.

Certification review sessions are free, but participants are required to register for the Module I exam and read the six-chapter study materials **PRIOR** to the sessions. Module I materials are available at a group discount rate of **\$320 (20% off the usual price)**. There is no additional charge for the exam. Module II is only available once you pass Module I and does not contain study materials. The cost of the Module II exam is **\$300**.

NJ HFMA will provide a secure wi-fi connection for all attending the sessions, but participants are required to bring their own laptops. Sessions will be held at the Borgata Hotel, Casino and Spa in Atlantic City, NJ at the 41st NJ HFMA Annual Institute event.

Upon completion of both Modules, the New Jersey or Philadelphia HFMA chapter will reimburse the cost of certification in full!
