This is the first edition of the **Cultural Mobility Funding Guide for the U.S.A.: Theatre, Dance and the Performing Arts**, produced by The Martin E. Segal Theatre Center, in partnership with On the Move and with the support of Theatre Without Borders. Published online on January 7th 2015.

This **Guide**, focused on **The United States of America** includes:

- **Funding opportunities open to U.S. nationals and residents › Outgoing mobility (OM);**
- **Funding opportunities open to nationals from other countries than the U.S.A › Incoming mobility (IM)**

The Guide lists national, local, and international resources, from both governmental and private institutions. Only opportunities accessible online with clear and accessible guidelines are listed; ad hoc or short-term funding are not included. The researchers have particularly put an emphasis on cultural mobility opportunities where travel is at least partially funded. The focus has been placed on opportunities related to theatre, dance, performance, and multi-disciplinary practices even if other disciplines can be covered as well.

The specific layout of this Guide is based on the guides co-produced by the cultural mobility information network On the Move. For a full overview of the methodology and scope of the research, please refer to the introduction, “How to read the cultural mobility funding guides” which can be found at: <http://on-the-move.org/funding/europe/>, which includes a definition of cultural mobility¹.

The main objectives of the cultural mobility funding guides are to make available, online, in a transparent way, the existing information on funding for the international mobility of **artists and cultural professionals**, as well as to give input to **public and private funders** on how to fill in the existing gaps in funding for international cultural exchange in order to ensure a sustainable support to cultural mobility in the U.S.A. and in the world.

This Guide is an attempt to gather most U.S.A. cultural mobility related resources in one document. It is a work in progress endeavor and is neither complete nor definitive. Feel free to send your comments, suggestions and corrections to: mestc@gc.cuny.edu

**Specific comments on the presentation of information included in the Cultural Mobility
Funding Guide for the USA: Theatre, Dance and the Performing Arts**

1. Organizations are listed in **alphabetical order under each main section (total of 6) introduced in the table of contents**. This method of presentation has been extensively discussed and agreed upon by the partners of this guide to tackle the complexity of funding schemes in the U.S.A. (e.g. private companies, individuals, public/private partnerships, etc.). For some organizations, specific information has been added to explain the origins of the funding (for instance, the regional art related commissions)².
2. **Foreign Cultural Institutions/Organizations** (from national cultural institutes to national bodies) have been listed to highlight some key countries' partnerships with the U.S.A. Some foreign funding schemes are also open to other international participation and not limited to the U.S.A.
3. Considering the limited funding options for the international mobility of artists and cultural professionals from the U.S.A. for projects abroad, **additional fellowships/scholarships and grants, as well as residencies** have been added when they are open to international individuals/organizations (including the U.S.A.).
4. A unique feature of this guide is the **inclusion of "Other Resources" (e.g. platforms/online resources and/or articles)** that are both useful for U.S. artists and cultural professionals when traveling abroad (and in particular to Europe) and for foreign artists/culture professionals coming to the U.S.A. This list is not comprehensive but it aims to open doors of knowledge and information for interested parties and organizations. To some extent, it responds to the need expressed by American artists, and culture professionals to access information about artists and culture organizations in Europe within the scope of the research done under the Preparatory Action on Culture in EU External Relations³.

² For instance, for the regional agencies, such as Arts Midwest, Mid-America Arts Alliance, Mid Atlantic Arts Foundation, New England Foundation for the Arts, South Arts, and Western States Arts Federation: "The Regionals today are private, non-profit entities serving regional areas that have been designed by the state arts agencies. Fifty-four of the fifty-six states and jurisdictions are currently participating in Regionals. The Regionals are funded by the NEA based on various formulas relating to the number of states in each region and historical data concerning support for performing arts touring. Funds for RAO's come from the amount of the NEA's appropriation that Congress sets aside for the "states and their regional organizations."
