ISSUES



Conflict & Atrocities Prevention encourages donor coordination to prevent instances of conflict and mass atrocities and respond to conflicts effectively if preventative efforts fail. (Co-hosted by the Peace and Security Funders Group)

Cross-Border Philanthropy promotes a more enabling environment for civil society through information exchange, research, donor advocacy, and collaboration. (Co-hosted with Ariadne and the European Foundation Center)

HIV & Human Rights exchanges strategies and pursues shared funding goals at the intersection of the human rights and HIV movements. (Co-hosted by Funders Concerned About AIDS)

Sexual and Reproductive Health & Rights explores issues such as non-discrimination and inclusion, access to sexual and reproductive health care and information, and freedom of decision-making and expression regarding sexuality, sexual orientation, gender identity, and reproduction.

POPULATIONS



Children & Youth Rights shares information, collaborates, and promotes children and youth rights as a component of a broader human rights strategy.

Disability Rights advances the rights of persons with disabilities, increases funding for and mainstreams disability rights into the broader philanthropic community, and promotes implementation of the UN Convention on the Rights of People with Disabilities. (Co-hosted with Ariadne)

Human Rights Defenders highlights critical concerns, promotes collaboration, and shares information on grantmaking strategies to support human rights defenders worldwide.


REGIONS



Asia & Pacific Funders discusses funding strategies, challenges, and opportunities related to supporting human rights in Asia and the Pacific. (Co-hosted with the EDGE Funders Alliance)

Latin America Funders shares news and events and discusses challenges and opportunities related to supporting human rights in Latin America.

GRANTMAKING PRACTICE



International Grants Operations develops solutions to emerging challenges in international grantmaking, particularly in light of increasing restrictions on civil society and foreign funding. (Co-hosted by Ariadne)

Learning, Monitoring and Evaluation advances monitoring and evaluation in the context of social change and strengthens human rights funders' monitoring and evaluation practices.

Participatory Grantmaking shares and increases the effectiveness of participatory grantmaking, and democratizes philanthropy by encouraging donors to become more inclusive in their funding practices. (Co-hosted by Ariadne)
