



## Citizenship Application Workshop – Bring List

Please bring the following to the workshop

- A **copy** of your **Permanent Resident Card** (also known as your “green card”) – both sides.
- Your **passport**, even if it is expired.
- Your **driver's license** or state identification card.
- Your **Social Security number** (we do not need the card itself).
- A list of your **residences** for the past 5 years.
