Official Sweepstakes Rules (“Official Rules”)

Making a purchase will not affect the odds of winning.

To Enter:

1. Sweepstakes Period: The Sweepstakes begins at 9:00 a.m. Eastern Time (“ET”) on November 20, 2017 through 11:59 p.m. ET December 20, 2017 (“Sweepstakes Period”).

2. Eligibility: To enter the Sweepstakes you (“Entrant”) must be a lawful permanent resident of the Continental United States or the District of Columbia, have reached the age of majority in the State within which you reside and hold a valid U.S. driver’s license. Sweepstakes void in Hawaii, Alaska, Puerto Rico, the U.S. Virgin Islands, U.S. territories, possessions, and military installations located in foreign countries, and where restricted or prohibited by law.
