**Additional work:** Coleman PowerSports is happy to provide additional services at the discounted rate while the vehicle is in for storage. However, any/all work performed during the storage period must be paid at the time of completion of the work.

All parts removed from units obtaining service work during winter storage will be disposed of unless picked up by the customer within 10 business days of completion of the work performed, not the end of the storage period.

**Insurance & Liability:** Coleman PowerSports assumes no liability for loss, damage, or destruction to the vehicle or its contents, due to collision, fire, theft, or otherwise, except damage directly attributable to the negligence of Coleman PowerSports. If Coleman PowerSports is negligent liability will be limited to the current fair retail used value. The owner of the above motorcycle **must maintain full coverage insurance during the storage term.** Coleman PowerSports prepares all vehicles for storage by performing the required winterization check in service and spring check out service. Coleman PowerSports will return the vehicle in the same condition received and will not be responsible for non-storage related concerns. The vehicle has been inspected and is in good condition except as noted on the vehicle condition form completed at check in.

**Retrieval of vehicle during storage:** Vehicle must be picked up during normal business hours by prior appointment. No person other than owner shall be authorized to retrieve the vehicle from storage. Owner may retrieve the vehicle prior to May 15<sup>th</sup> **but storage charges will not be prorated and are non-refundable.** Coleman PowerSports will need a minimum of 5 days notice to perform the check out service. The vehicle cannot be brought back into storage unless the check-in and check-out fees are re-paid.

**Penalty for late motorcycle pick-up:** Due to the limited space available during the normal riding season all motorcycles must be picked up at the dealership — or have a scheduled delivery completed by the dealership (subject to prepaid delivery fees)— no later than close of business on May 15<sup>th</sup> of this contract year. All motorcycles NOT picked up or delivered on or before May 15<sup>th</sup>, **will be subject to a \$20 per day storage fee.** Please provide more than a five (5) business day notice to the dealership to schedule any delivery.

**Monthly Payments:** I agree that the monthly storage fee of \$\_\_\_\_\_ will be automatically charged to my credit card, listed on the attached recurring credit card authorization form, on the 15<sup>th</sup> of every month. I may also use this credit card to pay for other services if I authorize Coleman PowerSports to do so. Coleman PowerSports will make one attempt to notify me at the above phone number if there are problems processing my payment. Any balance due for storage or repairs on the vehicle which are not received by Coleman PowerSports on or before five days when due shall subject the vehicle to lien sale proceedings pursuant to Virginia law. \$25 fee will be assessed for all denied credit cards each month.

**General:** No hazardous materials may be stored in the vehicle. This constitutes the entire agreement and supersedes all prior verbal or written agreements. This agreement shall be governed by the laws of the State of Virginia. All notices which may be required to be given will be sent to the above address unless a new address is provided. All other terms and conditions regarding our services on the repair order also apply.
