

Finally, over the last week, published reports have highlighted recent financial problems of Khader. Brian Herrod of the Yonkers newswire published three items concerning Khader's personal and business finances, and his fiduciary role as an attorney.

Public records show the New York State Department of Taxation and Finance issued two tax warrants after Khader failed to remit workers' compensation taxes for his employees. He was found guilty by default judgement and ordered to pay his back taxes with interest, penalties and fees.

Khader was also accused of being in derogation of his fiduciary responsibilities and obligations as an escrow agent in a lawsuit concerning a real estate transaction. Judge Nicholas Collabella ruled that Khader had to release \$6,000 in escrow funds. And last year, Khader was sued by American Express for a lack of payment in the amount of \$55,795 for his Amex bill.

There has been no comment from the Khader campaign on the reported financial woes, but Republicans and McLaughlin supporters claim it's fair game to discuss Khader's public documents about his past.

County executive candidate George Latimer has also come under scrutiny for owing \$46,000 in property taxes on a home owned by his deceased mother in law.

"Mike Khader says he wants the city to spend more of your tax dollars, but he couldn't pay his own American Express credit card bill," a McLaughlin supporter wrote on social media. "Amex took him to court seeking \$55,000 in unpaid credit card bills. How can we trust Mike Khader to manage the budget when he can't even manage his own? Yonkers taxpayers can't trust Mike Khader with another credit card."

The final debate between McLaughlin and Khader will take place Monday, Oct. 23 at 8:15 p.m. at Sarah Lawrence College, at the Reisinger Auditorium, sponsored by the East Yonkers Neighborhood Associations and co-sponsored by the League of Women Voters of the River-towns.
