

**SUMMER ASSIGNMENT
AP U.S. GOVERNMENT
2018-2019**

AS YOU KNOW, YOU ARE ENTERING INTO AN ENTIRELY REDESIGNED CURRICULUM AS WELL AS A REDESIGNED TEST FOR THE AP U.S. GOVERNMENT COURSE FOR THE 2018-2019 SCHOOL YEAR. THE NEW COURSE IS MORE FOCUSED ON PRIMARY SOURCES. YOUR ABILITY TO CONNECT THESE PRIMARY SOURCES TO TERMS, CONCEPTS, AND THEMES WILL BE MORE IMPORTANT THAN IT HAS BEEN IN THE PAST. WITH THIS IN MIND, THE SUMMER ASSIGNMENT IS HEAVY ON READING AND MAKING CONNECTIONS.

1. **READ EACH OF THE FOLLOWING PRIMARY SOURCE DOCUMENTS (ALL CAN BE FOUND ON THE INTERNET)—You must have a printed copy of each in a separate folder for the start of school. Think of it as a book with six chapters of various lengths.**
 - a. FEDERALIST PAPERS ARTICLES 10 AND 51
 - b. BRUTUS ARTICLE 1 (“ANTIFEDERALIST PAPERS”)
 - c. THE DECLARATION OF INDEPENDENCE
 - d. THE ARTICLES OF CONFEDERATION
 - e. THE CONSTITUTION AND ITS AMENDMENTS
 - f. LETTER FROM BIRMINGHAM JAIL

2. **A CASE A WEEK—EACH OF THE CASES FOUND ON THE THIRD PAGE ARE MANDATORY FOR THE REDESIGNED TEST NEXT YEAR. FOR OUR CLASS, EACH OF THE LISTED CASES WILL INCLUDE A RELATED CASE. YOU SHOULD BE ABLE TO COMPARE AND/OR CONTRAST THE REQUIRED CASE AND ITS RELATED CASE.**

3. **LAST BUT NOT LEAST, THROUGHOUT THE SUMMER IT IS IMPORTANT THAT YOU FOLLOW CURRENT POLITICAL EVENTS, ESPECIALLY THOSE AT THE NATIONAL LEVEL. YOU ARE TASKED WITH THE JOB OF FINDING TWO ARTICLES FROM CREDIBLE MAJOR NEWS OUTLETS (NEWSPAPERS, MAGAZINES, OR THE INTERNET) THAT DIRECTLY CONNECT TWO OR MORE OF THE MAJOR AREAS OF STUDY FOR NEXT YEAR. THESE AREAS OF STUDY INCLUDE:**
 - a. FOUNDATIONS OF AMERICAN DEMOCRACY**
 - b. INTERACTIONS AMONG BRANCHES OF GOVERNMENT**
 - c. CIVIL LIBERTIES AND CIVIL RIGHTS**
 - d. AMERICAN POLITICAL IDEOLOGIES**
 - e. POLITICAL PARTICIPATION**

FOR EXAMPLE, AN ARTICLE THAT ADDRESSES THE IMMIGRATION CONTROVERSY MAY COMBINE ELEMENTS OF CIVIL LIBERTIES AND CIVIL RIGHTS WITH INTERACTIONS AMONG BRANCHES AS WELL AS MAYBE EVEN AMERICAN POLITICAL IDEOLOGIES. IT MAY EVEN BE POSSIBLE TO FIND AN ARTICLE THAT ADDRESSES EACH OF THE MAJOR

AREAS OF STUDY. USING THE SAME IMMIGRATION ISSUE, THE ARTICLE MAY TALK ABOUT:

- LEGISLATION PROPOSED TO TACKLE THE ISSUE AND ITS CHANCES AT SUCCESS WITHIN THE LEGISLATIVE PROCESS**—INTERACTIONS AMONG BRANCHES
- THE IMPACT THE LEGISLATION MIGHT HAVE ON THE CIVIL RIGHTS OF UNDOCUMENTED IMMIGRANTS**—CIVIL LIBERTIES AND CIVIL RIGHTS
- THE POLITICAL IDEOLOGIES OF THE MAJOR PLAYERS WITHIN THE LEGISLATIVE PROCESS (IS IT A CONSERVATIVE OR LIBERAL APPROACH?)**—AMERICAN POLITICAL IDEOLOGIES
- THE IMPACT CIVIC PARTICIPATION MIGHT HAVE IN PRESSURING MEMBERS OF CONGRESS AND/OR THE PRESIDENT IN TAKING CERTAIN ACTIONS ON THE LEGISLATION**—POLITICAL PARTICIPATION
- THE ELECTORAL IMPACT OF THE LEGISLATION (ITS IMPLICATIONS FOR ELECTORAL SUCCESS FOR THOSE WHO MUST VOTE ON THE LEGISLATION)**—POLITICAL PARTICIPATION
- THE SPECIFIC PARTS OF THE CONSTITUTION INVOLVED IN DETERMINING HOW THE LEGISLATION MIGHT PROCEED AND WHETHER IT IS CONSTITUTIONAL OR NOT.**—FOUNDATIONS OF AMERICAN DEMOCRACY
- THE FRAMERS' PERCEIVED VIEW ON THE ISSUE**—FOUNDATIONS OF AMERICAN DEMOCRACY

I WILL GIVE YOU MORE SPECIFIC INFORMATION WHEN SCHOOL STARTS IN AUGUST. PRESENTATIONS WILL BE LATER IN SEPTEMBER.

Khan Academy has an updated site specifically for the AP U.S. Government course with detailed information covering all major subject areas including explanations of the primary source documents for which you are responsible. Although it is a little dry at times, it is very good at providing both an explanation with a transcript of what is being said. It also provides a quick explanation of what to expect on the exam at the conclusion of the program. The great thing about this site is that you can pick and choose topics as you wish.

Overall: There is so much information available out there to assist you in better understanding the primary sources you are to read over the summer. Just one piece of advice, if it is information that is providing you with opinion of a secondary nature, please try to be careful of its potential partisanship which might emphasize certain interpretations or passages within the primary source documents. **THERE IS NO WRITTEN ASSIGNMENT DUE WHEN YOU RETURN TO SCHOOL, BUT YOU WILL BE TESTED ON SOME OF THE MATERIAL AFTER LABOR DAY BREAK AND YOU WILL BE GIVING A PRESENTATION SOMETIME IN LATE SEPTEMBER. SO, READ AND PREPARE EARLY ENOUGH TO MINIMIZE THE DIFFICULTY OF DEALING WITH THIS STUFF LATER.**

I truly believe that if you throw yourself into this class from the start and pay attention to your political surroundings, that you will find this class extremely interesting, and most importantly, extremely valuable in the long run.
