

CALL TO ARTISTS

Refresh: Past, Present, Future

May 11th - June 2nd, 2018

Update, modernize, refresh and convert it. Reinvent or reprocess your art or artistic style. There is no time like the present to bring the past into your art. With an emphasis on found or salvaged objects this exhibition is open to **all mediums**.

ELIGIBILITY

You may submit if you're a San Diego area artist & your original work was made in the past 2 years.

ENTRY FEE

You may submit up to 3 pieces.

Members: \$20 for one, additional \$5 for each piece

Public: \$30 for one, additional \$5 for each piece

*Entry fees are non-refundable.

GENERAL PRESENTATION REQUIREMENTS

We strive to protect your work. To prevent possible damage to it, artwork must be appropriately prepared for exhibition when delivered.

1) Two-dimensional work must be wired with sufficient gauge to support the weight of the work and be ready to hang. If your work requires atypical hanging, please contact the Gallery prior to delivery dates for clearance. Special hanging, display and/or lighting requirements will be at the discretion of the EAP staff.

2) Installation and multiple piece works must include a simple diagram showing installation positions.

3) Work previously exhibited at the EAPMG will not be accepted.

4) Accepted artwork may not be removed before the end of the exhibition.

Artwork that fails to comply with entry requirements will be disqualified.

There is a 40% commission on works in the exhibition.

LIABILITY

By submitting I acknowledge that I have read and understand the general presentation requirements of the exhibition and will abide by them. The greatest possible care will be taken in handling art works. The EAP and/or their agents will not be responsible for loss or damage to any artwork submitted.

DELIVERY OF ARTWORK FOR JURYING

Work must be hand-delivered or mailed (with return postage and self-addressed box) no later than the receiving day.

PICK UP/STORAGE OF ART WORK

We have limited space for artwork storage. Non-accepted work must be picked up within one week after jury date. Accepted work must be picked up within one week of the end of the show. Work that has been accepted will be stored at the Gallery pending hanging of the show. Artwork remaining at the gallery 30 days after the end of the show for which it was submitted may be donated to charity.

JUROR

Wendy Morris is an art administrator at Sophie's Gallery. Sophie's Center created Sophie's Gallery 15 years ago. Morris started the art program on the main campus in 1994. The center offers a senior program, an adult development program, a behavioral modification program and a supported education program, all of which are funded through the state through the San Diego Regional Center, fundraising events and activities, donations and an endowment.
