a. Treasurer's Report – Larry Brongel

Cash balance is going down, probably down to \$20,000 by the end of August, and we may need to ask Sue J to transfer some funds, from the Antique Show and the Baker's Shelf.

Q. Why is the projected B & G costs higher in August? A. Higher insurance bills for December. Q. Do we have a comparison for usage /electricity since the A/C installed? A. Tom L. may be able to give us an idea.

i. Cindy Mottl moved to accept the treasurer's report. Mike Bolton seconded. The report was unanimously accepted.

b. Individual Reports

i. Senior Warden – Cindy Mottl

Has been looking at the phone system, as it was very difficult to follow. Medlin called to quote and will bundle all together. In the process we discovered that we had been paying for an AT&T line for \$366 per month, which was for a phantom alarm system, allegedly and historically claimed for an alarm system connection to the Fire Dept – totally untrue, and unnecessary – it will be cancelled with immediate effect. Also along the same alarm 'story' was a Tyco contract for \$77 a quarter (seemingly for the Insurance) Andy Dolliff (our Insurance agent) assures us both now necessary/non-existent. We do not have a functioning alarm system. When new system switched over, may change to Comcast. Also looking at our internet. The quotes include upkeep and maintenance.

ii. Committee Liaison Report Highlights

1. Buildings and Grounds

Red door still too light, and will be painted a darker color. The faulty air-conditioner in Memorial Hall will be replaced next season, approximate cost \$500.

iii. Dave Jackson

We will hold a Ministry Fair on September 10th, after both services meant to be informative and fun, but to raise excitement and provide information for various ministries. Coffee hour will not be at the back of the church on that day.

iv. Rev. Ellen

Requested who would be interested in attending the October Vestry retreat, for next vestry meeting.

3. Discussion

- Pipe Organ, new information has come to light whereby the pay schedule has changed; it is now mostly front loaded, because of the nature of the work, new negotiations are underway. Looking at brochure printing, for broader circulation/mailing. Will need to use some of organ funds for printing costs.
- Re: Coffee Mornings, Vestry may have to take up empty slots, suggested that help is enlisted with other parishioners. Requested coffee hour schedule to be sent again.

4. Decision

- a. Motion – To find a simpler and less expensive solutions to our phone and internet needs with the oversight of the wardens, rector, and buildings and grounds.

Asking for approval to go ahead with the purchase. Information given. Vestry agreed to purchase, with \$900 limit, and noted that it is and will be church property. Motion passed unanimously
