Section 3.06 Membership Dues and Fees:

Membership dues must be paid by personal check, personal debit or credit card or cash by the individual for himself/herself or for a family member (defined as spouse, children, parents and parents-in-law). However, new members must submit the membership application and pay the dues in person. Cash payments must be submitted in person. Applications submitted in the bundled form shall be invalid. Bundling is defined as one individual submitting application/renewals and payments for people other than himself/herself or for a family member. ADAMS Board has the discretion to approve or reject any membership applications.

FAQs

1. Can I split the membership payment over time?

No, unfortunately, partial or split payments will not be accepted.

2. Can I pay the membership fee on behalf of friends and neighbors?

Per the ADAMS By-Law Section 3.06, individual may apply for membership for a spouse, children, parents and parents-in-law only

3. Are membership dues tax deductible?

Membership dues are considered as a non-donation therefore, are not tax-deductible

4. When can I expect to receive my membership card?

All memberships are subject to approval by the ADAMS Board. Once approved, your card will be ready within 2 days.
