- **VENDOR BOOTH:** \$125 (Current Chamber Members: \$100), includes 3 vendor passes and parking passes
- You must furnish your own tent, tables, chairs, table cloths, etc. for your booth space.
- **NO ELECTRICITY PROVIDED.** You must bring your own generator, extension cords and gasoline. YOU must indicate on your application if you plan on using a generator.
- **Registration:** submit a list of items to be sold, photos of items and a recent photo of your booth at a similar event. Please submit photos to director@marshallchamber.org. It is best to email photos for best quality on social media showcasing.
- Make registration checks payable to: Rusted Magnolia and mail to P.O. Box 1908, Lewisburg TN 37091
- No refunds if you, the vendor choose not to set-up after the deadline date. Applications submitted without payment will not be processed. Photos of items and booths are required if you are a returning vendor so that your latest items can be seen and to avoid reposting the same pictures from the 2016 event.
- If applications are received after the deadline of March 17, 2017, there will be a \$25 fee accessed to the vendor fee and the committee will consider your application for approval and notify you by email.
- Security will be provided.
- Event set-up and tear-down: You may arrive to set-up on Thursday, April 20th between 10 am—2 pm. You may tear down at the close of the event on Saturday.
- **Vendor Parking:** There will be no vendors allowed to park beside their tents or in the Marketplace area. Vendor parking will be in a close designated area near the sale area.
- **Sales Tax:** The collection and payment of any and all Sales Tax is the sole responsibility of the vendor. Rusted Magnolia Marketplace at Jubilee Hills assumes no responsibility regarding the collection, reporting and/or remittance of sales tax for sales by vendors.
