### Early Childhood Courses at Granite State College

Tuition assistance through the Early Childhood Tuition Assistance grant is available to teachers working a minimum of **20 hours** per week and directors working a minimum of **30 hours** per week in a NH licensed child care program. The grant may be applied toward one course each semester. You must complete an application each semester you wish to participate in the grant. Funds are allocated on a first come first basis, with priority given to students without a bachelor's degree applying for Child Growth and Development or Young Children with Exceptionalities.

Students are required to complete a withdrawal form if they wish to withdraw from the course after the add/drop timeframe. You can find the official withdrawal form at <http://my.granite.edu/registrationchange>. \*All withdrawals will have their award money removed from their account and will be billed the total cost of the course.

If you do not participate in a course after registering, you will earn an Academic Failure and will be charged the total cost of the course.

In-state tuition is \$1256 (Out-of-state is \$1420) per 4 credit course. In addition, a \$75 Registration and Academic Support fees (not included in grant) is required. 500 level course taken through the grant have been discounted to \$840, if you receive half tuition you will only be required to pay \$420 plus the registration fee.
