On behalf of The Council of State Governments West (CSG West), we are writing to encourage you and your administration to modernize the North American Free Trade Agreement (NAFTA) to meet the needs and challenges of the 21<sup>st</sup> Century. State lawmakers across our 13 western states know first-hand the importance of trade on their economies, and we share your goal of growing jobs and strengthening communities across America.

Since the implementation of NAFTA, U.S. trade with Canada and Mexico has created the most powerful economic bloc in the world, jumpstarting industry and spurring innovation. Today, trade with Canada and Mexico supports approximately 1.1 million jobs in the American West, and all but one of CSG West's states count either Canada or Mexico among their top three export markets.

NAFTA touches the lives of hard-working Americans across a wide spectrum of our society. It has been particularly integral to Americans that raise and grow our food. In our Western contiguous states, approximately 7.5% of the labor force directly depends on NAFTA for their jobs. Our trade relationship with Mexico and Canada has benefited small- and medium-sized businesses that form the backbone of our country, and the integration of American supply chains that have led to specialization in our industries and communities. An integrated production system in the automotive industry that includes suppliers and plants in Mexico and Canada has led to a shared production model which are not advantages other trading blocs have.
