Full payment is required as indicated on the Reservation Coupon and Final Invoice. \$50 Return Check Fee.

**CANCELLATIONS:** Cancellations will only be accepted in writing via email to [info@iltgolf.com](mailto:info@iltgolf.com). (Verbal cancellations NOT accepted.) Cancellations received 81 days or more prior to departure are levied a \$50 per person fee. 80-61 days prior to departure cancellation fee is 25% of tour cost. 60-31 days prior to departure, cancellation fee is 75% of tour costs.
