

NATIONAL BLACK POLICE ASSOCIATION PROFILE

NBPA HISTORY

In November 1972, the National Black Police Association was chartered as a not-for-profit corporation in the state of Illinois following the historic meeting in St. Louis, Missouri. There were thirteen African American Peace Associations present at the meeting with 109 representatives from the host city as well as: New York City and Buffalo, New York; Flint and Detroit, Michigan; Richmond, San Francisco, and Los Angeles, California; Cincinnati, Akron, Dayton, and Cleveland, Ohio; Chicago, Illinois; Philadelphia and Pittsburgh, Pennsylvania; New Orleans, Louisiana; Baltimore, Maryland; Newark, New Jersey; Bridgeport, Connecticut; Louisville, Kentucky; and Denver, Colorado.

The National Black Police Association was established

To improve the relationship between Police Departments as institutions and the Black community;

To evaluate the effect of the policies and programs within the Criminal Justice System upon the Black community;

To serve as a mechanism to recruit Black police officers on a national scale;

To work toward police reform in order to eliminate police corruption, police brutality and racial discrimination; and

To educate police officers to perform with professionalism and compassion.

The NBPA established five geographical regions throughout the United States and each of these regions operates and maintains an office. Each region elects an Executive Committee that represents all of the NBPA chapters and individual members in their respective regions. The regions are comprised of the following states...

NORTHEAST REGION

Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island, and Vermont.

EASTERN REGION

Delaware, District of Columbia, Kentucky, Maryland, North Carolina, Ohio, Pennsylvania, South Carolina, Tennessee, Virginia, and West Virginia.

SOUTHERN REGION

Alabama, Arkansas, Colorado, Florida, Georgia, Louisiana, Mississippi, New Mexico, Oklahoma, and Texas.

MIDWEST REGION

Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, South Dakota, and Wisconsin.

WESTERN REGION

Alaska, Arizona, California, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, Washington, and Wyoming.

The NBPA National is governed by a Board of Directors. The formulation of policy and operations of the NBPA is the sole responsibility of the Board of Directors. The NBPA National Officers are elected from members of the Board of Directors.

The NBPA maintains and operates a National Office in Washington, D.C. The NBPA National Office formulates, coordinates and monitors nationally funded projects and programs. The National Office is the administrative arm of the National Board of Directors and is supervised by an Executive Director.

The NBPA hosts an Annual Education and Training Conference for its members and others interested in law enforcement. The conference is designed to provide workshops, discussion groups, and the dissemination of pertinent information to those who attend. The conference also provides an opportunity to network with fellow officers from across the country.

The organizational imperative of the NBPA is to bridge the gaps - both real and perceptual - between law enforcement as institutions and the Black community through mutual cooperation, trust, and positive interaction.

NBPA MISSION STATEMENT

To increase the awareness of the community;
to be the conscience of the Criminal Justice System; and
to enhance the quality of life in the African American Community

NBPA POSITIONS

COMMUNITY POLICING - The NBPA supports the philosophy of true Community Policing that calls for a cooperative partnership between the community and the police to build and maintain safer and sustainable communities.

CONTROL of ILLEGAL NARCOTICS - The NBPA believes that the influx of illegal narcotics into this country can only be controlled by a joint effort between the supplying country and our federal government. The NBPA supports a domestic policy that embraces proactive prevention, lawful interdiction and on-demand treatment.

CRIME PREVENTION - The NBPA supports the equitable allocation and distribution of more national and local crime fighting resources toward the prevention and abatement of crime.

DEATH PENALTY - The NBPA protests the application of the death penalty in all instances. The NBPA feels the death penalty is unconstitutional, unjust, and un-American.

HANDGUN CONTROL - The NBPA supports restrictive national handgun and assault weapon legislation that prohibits the further manufacturing, sales, possession, and use of these weapons.

POLICE BRUTALITY - The NBPA believes that police brutality must be confronted, controlled, and outlawed by all police departments throughout the United States.

POLICE RESIDENCY - The NBPA believes that police officers should be required and have their residency in the jurisdiction in which they are employed.

WOMEN IN POLICE WORK - The NBPA supports women as equal and equitable partners in the field of law enforcement and also believes them capable of performing equally as well as their male counterparts.

AFFIRMATIVE ACTION - The NBPA supports affirmative action to correct workplace inequities borne out of historical and institutional discrimination and disparate treatment in the hiring, training, assignment, discipline, and promotion of peace officers of color and more specifically, African American peace officers.

RACIAL PROFILING - The NBPA supports federal racial profiling legislation that...

- Mandates the collection of statistical data to determine frequency and adverse impact; and
- Imposes joint liability on agencies and their employees showing patterns and practices of using race-based profiles exclusively - without sufficient cause - to stop, detain, harass, search, arrest, prosecute citizens and seize property.
