



What Does Your Church's 2018 Giving Make Possible in Trinity Presbytery?

Trinity Presbytery IS its 61 member churches. Because of the connectional nature of the Presbyterian Church (USA), our churches together support the missions and ministries of Trinity Presbytery in ways that could never be done separately.

Each church supports mission and ministry by Per Capita giving and supporting the Unified budget of Trinity Presbytery. Explanations of these two components of giving follow.

The Per Capita (per member) apportionment has three parts: General Assembly (\$7.73), Synod (\$1.50) and Presbytery (\$4.00). The total Per Capita amount of \$13.23 multiplied by total church membership determines total Per Capita owed for the year. The church membership is that which the church reported on the 2016 statistical report.

- **General Assembly per capita of \$7.73** funds the national ecclesiastical functions of the PC(USA), including the biennial meetings of the General Assembly, the meetings and task forces the Assembly creates, including the GAMC, the church's court system and constitutional services, the Presbyterian Historical Society, and the record- and document-keeping of the denomination.
- **Synod per capita of \$1.50** funds mostly Synod grants to presbyteries - mostly new church and church redevelopment grants
- **Presbytery per capita of \$4.00** to fund Presbytery programs and Unified budget.

Churches are asked to make a commitment to Trinity Presbytery to support the Unified budget. Again this year we are using the Fair Share concept because it is the fairest, most consistent way to encourage all the congregations in our Presbyterian family to support proportionately the work we do together. It is the Biblical approach to Christian giving. The 1998 General Assembly voted unanimously to urge every congregation to adopt the plan. Simply stated, it calls on each Church to support the work we do as Presbyterians by giving a Tithe (10%) of the amount of regular undesignated contributions your church received in 2016 as reported on the General Assembly Statistical Report. **The Fair Share, or Tithe, funds the Unified budget of Trinity Presbytery, including benevolences.** Those budgeted items include:

New Worshipping Communities
Sudan Ministry
USC Campus Ministry
Pastor salary sustentation/church loan assistance

Benevolences to Institutions
Migrant Ministry
Scholarships for seminary students
Presbytery office and staff

Thank you for your continued support for the mission and ministries we are doing together. We will continue to be the hands and feet of Christ together in Trinity Presbytery.
