Our Savior's Lutheran Church January Council Meeting Minutes (unapproved)

The January 16, 2018 OSL meeting was called to order at 7:00 pm by President, Sharon Nelson. Pastor Janet opened with a prayer.

Attending: Pastor Janet, Sharon Nelson, Katie Benson, Kaitlin Barbosa, Tony Johnson, Mike Miller.

Absent: Travis Hanel, Amanda Liebersbach.

This month's agenda and last month's meeting minutes: Kaitlin made a motion and Mike seconded, to approve this month's agenda with some additions and last month's meeting minutes, motion carried.

Treasurer's Report: Tony made a motion to approve the treasurer's report, Katie seconded, motion carried.

Pastors' Reports: Pastor Janet made 6 nursing home visits, 10 hospital visits, 4 homebound visits, and there are 2 prospective families. There is a wedding planned for January, one upcoming baptism for Rhett Pierce on January 28th, and the most recent funeral was for David Duckstad. Pastor Janet discussed the upcoming Worship Calendar which includes the Youth Leadership Sunday and the Annual OSL Meeting will be on January 28th, Scout Sunday on February 4th, and the 1st Sunday in Lent is February 18th. Lenten services at OSL will be at 7pm as follows: Ash Wednesday is on February 14th, March 7th with a Soup Supper, Maundy Thursday on March 29th, Good Friday service on March 30th, and Easter Sunday is April 1st.

Tony made a motion to try for this year in lieu of having the Sunrise service, to have the youth serve the Easter breakfast at around 9:30 am and have one Easter service at OSL at 10:45 am, Katie seconded, motion carried.

Pastor Ron and Pastor Janet have completed all homebound visits for December. There are 39 on the

homebound list. There are five on the prayer list for the Parish. Kaitlin made a motion to approve the Pastor's reports, Mike seconded, motion carried.

Committee Reports:

Stewardship: The stewardship committee has not met recently.

Worship and Evangelism: The committee met January 16th. There are a few poinsettias remaining that members can take home if they wish. Joan has written a letter to the council to have internet available at the front of the church that might cost \$200.00 in order to use internet based music programs. Tony made a motion to install cable in the choir area so that internet can be available, Kaitlin seconded, motion carried.

Education & Youth: The youth will be presenting an Easter Program on Palm Sunday. Upcoming events are being planned for the youth through March. There has been good attendance of the youth at the Confirmation classes.

Property and Management:

Tony has requested that the city provide a price to him for the cost of replacing the flag poles to match the flag poles at the fire department. There were two U.S. flags donated to OSL.

There is progress being made on the narthex table.

The council will look at hiring professional cleaners to do a deep cleaning of the church in the summer after Vacation Bible School.

Discussed the tape on the Sanctuary doors and that the doors should be revarnished, which Pastor Janet will look into further.

Pastor Janet will discuss with WELCA their thoughts on replacing the table and chairs in the basement.

At this time, the consideration of new furniture in the library will be tabled as the property and man-

agement priorities will be the following: replacing the narthex table, revarnishing the sanctuary doors, replacing the flag poles, placing carpet on the west entry stairs, replacement of the basement tables and chairs, and replacement of the alley windows.

Katie made a motion to approve the committee reports, Kaitlin seconded, motion carried.

Old Business:

New members for Council: Tony Johnson will stay on for three more years. Katie Benson will stay on for one more year. The council members will remain the same as the last year.

OSL annual meeting: The OSL annual meeting will be held on January 28th after the 10:45 am service.

New Business:

Review of Budget for 2018: The council reviewed the proposed 2018 budget and made adjustments. Katie made a motion to accept the 2018 proposed budget with adjustments made, Tony seconded, motion carried.

Appointment of Audit Committee: Mike made a motion to approve Elva Bustrack, Wayne Spidahl, and Darrell Rindy as the audit committee, Kaitlin seconded, motion carried.

ODC Contract: Tony made a motion to approve the ODC contract for weekly general cleaning, Mike seconded, motion carried.

Communion Servers:

February 4th: Katie, Travis, Kaitlin. February 18th: Mike, Tony, Jim.

The next council meeting will be held on February 13, 2018 at 7:00 pm. Katie made a motion to adjourn the meeting at 9:40 pm, Kaitlin seconded, motion carried.
