## **Important Event Information and Event Waiver**

Vendors may setup between 8:30AM -9:45AM on November 3<sup>rd</sup> 2018, and are responsible for set up and tear down of their equipment. Display items that are left on tables are done so, at vendors (named below) own risk, and TMW Productions, LLC and the Town of West Warwick will not be held liable for lost or stolen property. Merchandise, signage, decorations or display fixtures shall not be pasted, taped, nailed, or tacked to walls or ceilings. All items that are part of the booth and/or display must remain in the 6'x6' display space, unless prior express permission has been obtained before the event. The basic event space includes one 6' table and two chairs. Vendors are responsible for bringing table cloths, display items, and signage. Use of and/or the operation of machinery in displays which involves exceptionally loud noises is not permitted. Dismantling a booth may not begin until 2:00PM.

If a cancellation occurs, before July 1<sup>st</sup> 2018, 100% of monies paid will be refunded. If a cancellation occurs between July 1<sup>st</sup> 2018 and September 1<sup>st</sup> 2018, 25% of monies paid will be refunded. After September 1<sup>st</sup> 2018, no refunds will be issued. If booth space is not occupied by 11:00AM on the event day, TMW Productions, LLC reserves the right to use the space as it sees fit. In the event TMW Productions, LLC postpones the event, the event will be rescheduled up to two additional times before a full refund is issued to vendors. If the event is postponed, or the original event space becomes unavailable, TMW Productions, LLC reserves the right to move the location of the event, not more than 50 miles from the original planned event location.

Vendors who purchase advertising agree to provide a print ready logo or advertisement, and to submit it by October 1<sup>st</sup> 2018. Vendors also agree to the use and reproduction of the logo or advertisement. If a logo or advertisement is not received by October 1<sup>st</sup> 2018, the vendor will forfeit all advertising options selected and no refund will be issued.

The vendor assumes all risks associated with participating in the Pawtuxet Valley Wellness Day event. The vendor waives and releases TMW Productions, LLC and the Town of West Warwick and its officers, employees, and agents from all claims or liabilities of any kind arising from the vendor's participation. The vendor understands such liability may arise out of negligence or carelessness on the part of the vendor named in this waiver. I acknowledge that TMW Productions, LLC and its directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting or assisting in conducting a specific activity or event on their behalf. This Waiver and Release shall be governed by and construed in accordance with the laws of the State of Rhode Island applicable in the case of agreements made and to be performed entirely within such State. Any dispute, issue or disagreement arising under this Waiver and Release or any such factual scenario involving this Waiver and Release shall have sole and exclusive venue in the Rhode Island Superior Court. If and to the extent that TMW Productions, LLC is prevented from executing the services herein this agreement and complete the event due to the event of Force Majeure (Act of God), such as, but not limited to, fires, explosions, earthquakes, drought, tidal waves, floods, war, hostilities (whether war be declared or not), invasion, act of foreign enemies, mobilization, requisition, embargo, rebellion, revolution, insurrection, military or usurped power, civil war, contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic explosive, or other hazardous properties of any explosive nuclear assembly or nuclear component of such assembly, riot, commotion, strikes, go slows, lock outs or disorder or acts or threats of terrorism, TMW Productions, LLC shall be relieved of its obligations to provide the services but shall endeavor to continue to perform its obligations under the Agreement so far as reasonably practicable.

TMW Productions, LLC and their representatives reserve the right to extend and reject any and all registration forms. The vendor agrees to carry Commercial General Liability insurance in an amount not less than \$1,000,000 per occurrence. If requested by TMW Productions, LLC the vendor agrees to provide evidence of such insurance.
