Advanced registration is required for attendance and the completed form must be received by December 8, 2016. We will send you confirmation of your registration as well as a schedule for the day by December 19th. IMPORTANT FAFSA INFORMATION

Many of you are aware about the change in completing the [Free Application for Federal Student Aid \(FAFSA\)](#). Students and parents were able to complete their FAFSA beginning October 1, 2016, much earlier than in the past. Several million students already have their FAFSA filed for the fall of 2017.

From the Federal Website: Starting with the 2017–18 FAFSA, the application is available earlier and requests prior-prior-year income information.

- The 2017–18 FAFSA became available for applicants to fill out beginning on Oct. 1, 2016. This is three months earlier than the traditional FAFSA launch date of Jan. 1.
- The October launch date will continue in subsequent years.

The 2017–18 FAFSA requests **2015** tax returns. Traditionally, the FAFSA has requested information from the tax return due near the beginning of the application cycle. For instance, the 2016–17 FAFSA requires 2015 tax information, which some applicants did not have available in time for school or state deadlines that fell early in 2016. Subsequent FAFSAs will request data from tax returns that should already have been filed (prior-prior-year), simplifying the process for applicants.

Students with questions should reach out to the Financial Aid Office at their college of choice. Many colleges and universities have made their deadlines much earlier to comply with this national initiative so the normal deadlines you are used to, may no longer be valid.
