**Food Booth Fee**

Booth fees are a flat rate. We no longer charge a commission on sales. Booth fees are as follows:

\$1000 per 10'x10' Single Item Space (i.e. Kettle Corn)

\$1200 per 10' x 10' space

\$1500 per 20' x 10' space

\$1800 per 30" x 10' space

**Please complete the online application by Friday, March 17th to be considered for this event. Vendors will be notified by Wednesday, March 29th of acceptance.**

**Electrical Requirements**

The Festival will provide 20 Amp outlets for \$150 each.

**Equipment**

Food vendors are responsible for their own canopies, lights, tables, signage and coolers.

**Insurance**

All food vendors must provide a certificate of insurance for \$1,000,000 naming the Washington Beer Commission and King County Parks as additionally insured parties. Certificates are due Friday, May 5th, 2017

**Permits**

Food vendors are responsible for acquiring your own health permit, food handlers permit, propane permit and any other permits required to operate your booths. Please contact the appropriate offices to make the arrangements. Vendors cannot operate a booth without proper permits at the Festival.

**Washington Business License**

All vendors must have a current Washington State Business License valid June 16th-18th, 2017. Please provide your UBI number on the application form. If you do not have one, a temporary permit is available at no charge at the Washington State Department of Revenue.

**Booth Restrictions**

Due to space limitations the entire operation of your booth including cooking and storage must fit entirely in the space provided. Food vendors are responsible for cleaning up their space afterwards. Please maintain a clean and professional environment. Handwritten signs are not allowed.

**Food Vouchers**

The Festival will issue approximately 40 food vouchers per vendor to the festival staff who make our Festival possible. We ask all the food vendors to honor the vouchers to help support our event staff.

**Ice**

Ice will be available in 40lb bags for \$10.00 each for food vendors.

**Load-in/Load-out**

Food vendors can set up booths on Friday, June 16<sup>th</sup> and Saturday, June 17<sup>th</sup>. All vendors must be loaded out and cleaned on Sunday evening after closing of the event. **You will receive detailed load-in/out information a few weeks before the Festival.**

**Vendors who are selected for the event will be notified by Wednesday, March 29th.**
