It was designed and built for heavy manufacturing of carbon and alloy steel products and was formerly used for the manufacture of Cryogenic Vessels.</p> <p>The four manufacturing buildings total approximately 100,000 square feet of crane served manufacturing space with 16 overhead bridge cranes and 37 overhead rollup doors. Eave heights range from 26 to 32 feet and the overhead cranes range from 5 tons to 30 tons with up to 22 foot clear height under hook. Most of the bays in each manufacturing building are equipped with multiple power feeds ranging from 110 volt to 480 volt, compressed air, and inert gas connections.</p> <p>The facility is located just over one half mile north of I-10 off of Hwy 146 in the industrial district of Mont Belvieu. Many major petrochemical industrial facilities including Chevron-Phillips, Enterprise Products, EXXON-Mobil, TARGA, Equistar and ONEOK are within a 3-mile radius of the facility.</p> | | | | |
