COUNT 4

On or between March 8, 2016 and May 5, 2016, in the County of Los Angeles, the crime of VOTER FRAUD – REGISTER NONEXISTENT PERSON, in violation of ELECTIONS CODE SECTION 18102 was committed by RICHARD THOMAS HOWARD, ROSE MAKEDA SWEENEY, CHRISTOPHER JOSEPH WILLIAMS, KIRKLAND KAUZAVA WASHINGTON, HAROLD BENNETT, LOUIS THOMAS WISE, JAKARA FATI MARDIS and NORMAN HALL, who knowingly registered a non-existent person, a person under a false name or address, or a person who is ineligible to register.

On or between May 15, 2018 and May 17, 2018, in the County of Los Angeles, the crime of CIRCULATE INITIATIVE/PETITION W/FALSE NAMES, in violation of ELECTIONS CODE SECTION 18611, a Felony, was committed by HAROLD BENNETT, LOUIS THOMAS WISE and NICKEY DEMELVIN HUNTLEY, who circulated or caused to be circulated an initiative, referendum, or recall petition, knowing it to contain false, forged, or fictitious names.

COUNT 6

On or between May 15, 2018 and May 17, 2018, in the County of Los Angeles, the crime of USE FALSE/FICTITIOUS NAME ON PETITION, in violation of ELECTIONS CODE SECTION 18613, a Felony, was committed by HAROLD BENNETT, LOUIS THOMAS WISE and NICKEY DEMELVIN HUNTLEY, who caused another to subscribe a false name to an initiative, referendum, or recall petition.

COUNT 7

On or between May 15, 2018 and May 17, 2018, in the County of Los Angeles, the crime of VOTER FRAUD - REGISTER FICTITIOUS PERSON, in violation of ELECTIONS CODE SECTION 18101, a Felony, was committed by HAROLD BENNETT, LOUIS THOMAS WISE and NICKEY DEMELVIN HUNTLEY, who knowingly and willfully caused or procured the completion of, in whole or in part, an affidavit of registration or a registration voter card, with the intention to cause the registration or reregistration as a voter.

On or between May 15, 2018 and May 17, 2018, in the County of Los Angeles, the crime of VOTER FRAUD – REGISTER NONEXISTENT PERSON, in violation of ELECTIONS CODE SECTION 18102 was committed by HAROLD BENNETT, LOUIS THOMAS WISE and NICKEY DEMELVIN HUNTLEY, who knowingly registered a non-existent person, a person under a false name or address, or a person who is ineligible to register.

COUNT 9

On or between September 19, 2018 and September 19, 2018, in the County of Los Angeles, the crime of CIRCULATE INITIATIVE/PETITION/ETC W/FALSE/ETC NAMES, in violation of ELECTIONS CODE SECTION 18611, a Felony, was committed by KIRKLAND KAUZAVA WASHINGTON, who circulated or caused to be circulated an initiative, referendum, or recall petition, knowing it to contain false, forged, or fictitious names.

COUNT 10

On or between September 18, 2018 and September 18, 2018, in the County of Los Angeles, the crime of USE FALSE/FICTITIOUS NAME ON PETITION/ETC, in violation of ELECTIONS CODE SECTION 18613, a Felony, was committed by KIRKLAND KAUZAVA WASHINGTON, who caused another to subscribe a false name to an initiative, referendum, or recall petition.

On or between September 19, 2018 and September 19, 2018, in the County of Los Angeles, the crime of VOTER FRAUD - REGISTER FICTITIOUS PERSON, in violation of ELECTIONS CODE SECTION 18101, a Felony, was committed by KIRKLAND KAUZAVA WASHINGTON, who knowingly and willfully caused or procured the completion of, in whole or in part, an affidavit of registration or a registration voter card, with the intention to cause the registration or reregistration as a voter of a fictitious person or of any person who has not requested registration or reregistration as a voter.

COUNT 12

On or between September 19, 2018 and September 19, 2018, in the County of Los Angeles, the crime of VOTER FRAUD – REGISTER NONEXISTENT PERSON, in violation of ELECTIONS CODE SECTION 18102 was committed by KIRKLAND KAUZAVA WASHINGTON, who knowingly registered a non-existent person, a person under a false name or address, or a person who is ineligible to register.
