NH Children's Trust seeks partners to bring training in the Strengthening Families Framework to areas around the state. Proficiency in the Strengthening Families Framework can increase the quality of the services provided to children and families, as well as enhance the quality of life in your community.

Where the training is offered depends on NH Children's Trust identifying a strong local partner. We have an underwriter and can offer the training at no cost to participants to at least 5 sites. Host Partner Responsibilities:

- Assure at least 25 participants will complete the training by facilitating participation of own employees, actively outreaching to your wider provider network, and cultivating relationships with other community professionals.
- Identify a main contact to stay in touch with NH Children's Trust for planning the training.
- Provide or arrange for a training space that will accommodate up to 40 participants that has
 - Adult seating conducive to a full-day training
 - A Screen or white wall onto which a PowerPoint can be projected
 - A table for presenters to organize materials
 - A small table for projector
 - A table for sharing resources and other participant needs
 - Accessibility for participants with disabilities
 - Adequate electricity
 - Adequate Parking (ideally low or no cost)
 - Capacity for participants to bring lunch in (either brown-bag or local take-out)
- Someone on-site during training (or easily accessible) to address facility needs. (Can be participant in training)

NH Children's Trust Responsibilities:

- Coordinate registration of all participants with on-line registration
- Conduct a training with 2 trainers certified by the National Alliance of Children Trust & Prevention Funds.
- Work with host to determine format and scheduling of training.
- Bring all technology (except specified above) and materials needed for the training
- Provide a resource book for implementing the Protective Factors Framework to each participant
- Provide training certificates to each participant after each training session which will award:
 - Professional Development Hours for early care & education professionals
 - Contact hours for nurses in related field
 - CEU's for those licensed by the NH Board of Mental Health Practice and NH Guardian ad litem Board (subject to approval of each training held)
 - Training hours for other professionals
- Promote the training to the media, on the NH Children's Trust website, via social media, to other state-level partners and known local partners.
- Provide tools to help host promote training series including flyers, press-releases, list of ideas of potential targets of promotion, and other customized promotional materials.
- Technical Assistance and follow-up after the training so that your organization/community can meet their goals regarding embedding the Strengthening Families Framework.

Host Partner Guiding Questions

1. Please think about and be prepared to discuss each of the hosting responsibilities listed above and your organization's capacity to meet them. We hope that you'll think about existing relationships and networks which you could draw on in meeting the responsibilities. Community partnership and collaboration is encouraged and we welcome trainings that are joint ventures between more than one agency. We are eager to work with local partners. If there is a responsibility that you cannot meet, or you will need significant support from the Children's Trust to meet, please be prepared to speak to that. This will not necessarily rule out a partnership, just inform setting realistic expectations for the partnership.
