The budgetary assumptions are clearly identified, as are our projected membership financial commitment requests.

Our successes will continue if every member family supports our synagogue within their personal means. Our commitment to inclusion recognizes that this will mean different things for different families. But our community's continuing health rests in your hands. So please support fundraising activities, make the temple one of your philanthropic priorities, and understand that while we want to give congregants financial assistance as is necessary, we need every congregant, in turn, to be committed to the welfare of our community at large.
